INTRODUCTION

The South Central Planning and Development Commission (SCPDC) prepared an Overall Economic Development Plan (OEDP) in 1997 and subsequently prepared an annual update to it in 1998. That OEDP was prepared in accordance with guidance of the Economic Development Administration (EDA). It provided an overall picture of the six parish regional economy and strategies for attaining goals spelled out in the plan. In 1998 Congress enacted the EDA Reform Act changing the landmark OEDP process to the new Comprehensive Economic Development Strategy (CEDS). The CEDS process has much in common with its predecessor, it will be completely updated every five years and annual updates are prepared in the interim documenting progress on economic development activities undertaken in the region and reporting changing economic development conditions. While the Reform Act requires the approved CEDS in order to obtain further funding assistance through the EDA, the value of the process for economic development practitioners and planners should not be overlooked.

The Reform Act set as its objectives the creation of jobs, the fostering of more stable and diversified economies, and improved living conditions. The CEDS will thus be a mechanism for coordinating the efforts of those concerned with economic development. The CEDS will comprise four main elements, analysis, vision, action plan, and evaluation. The strategy analyzes the regional economy and looks at external trends and forces. It identifies partners and resources for economic development. The vision is a statement of the region's goals; "Where do we want to be?" An action plan is developed as a way to attain the goals. Finally, an ongoing evaluation of the CEDS is made to determine what improvements or changes should be made in the strategy.

The SCPDC 1997 Overall Economic Development Plan covered much of the content required by the new CEDS format. New to the CEDS program will be standards for evaluation. This 1999 Annual Report will be presented in a fashion to act as a transition between the OEDP and the CEDS. Thus it will contain features common to both and will provide an evaluation process for this and forthcoming years. The report is divided into the following sections.

- 1. Adjustments to the CEDS. Adjustments are made to the implementation strategy outlined in 1997 to account for unforeseen opportunities or unexpected problems. Changes in the structure or composition of local and regional economic development committees are reported.
- 2. Report on the previous year's economic development activities and any significant changes in the region's economic conditions. Activities undertaken in the previous year are documented in relation to the needs and objectives identified in the 1997 strategy and the objectives of the 1998 Reform Act.
- 3. Annual Evaluation. A proposed guide for evaluation of the effectiveness of the CEDS in meeting goals and objectives is provided.
- 4. Next Year's Goals. A program of achievable activities for the upcoming year is provided. A brief discussion is provided for each in order to show how it is related to the goals and objectives of the 1997 OEDP and the 1998 Act.

The State of Louisiana has also set new goals for economic development. Louisiana 2020 Goals has three goals that mirror those of the 1998 Reform Act.

<u>Goal One:</u> To be a Learning Enterprise in which all business, institutions, and citizens are actively engaged in the pursuit of knowledge, and where that knowledge is deployed to improve the competitiveness of businesses, the efficiency of governmental institutions, and the quality of life of citizens.

<u>Goal Two:</u> To have an economy driven by a diverse and thriving set of technology-intensive industries that actively utilize Louisiana's colleges and universities as a source of well-educated graduates as employees, a source of expertise for problem-solving, and a source of technology for commercialization.

<u>Goal Three:</u> To have a standard of living among the top ten states in America and safe, healthy communities where rich natural and cultural assets continue to make the State a unique place, to live, work, visit, and do business.

In developing and refining goals and objectives, the SCPDC remains cognizant of the general purposes established by the EDA and the State's 2020 Goals.

ADJUSTMENTS TO THE 1997 OEDP

The goals of the 1997 OEDP were changed in order to better present an overall strategy for achieving a sustainable economy. It was felt that 22 goals is cumbersome and that in order to better evaluate progress in achieving these goals, they could be better stated in five very broad goals that the entire district is attempting to achieve. The adopted goals for the South Central Region are those of the State of Louisiana and two others particular to this region as follows:

Goal One: To be a Learning Enterprise in which all business, institutions, and citizens are actively engaged in the pursuit of knowledge, and where that knowledge is deployed to improve the competitiveness of businesses, the efficiency of governmental institutions, and the

quality of life of citizens.

Goal Two: To have an economy driven by a diverse and thriving set of technology-intensive

industries that actively utilize Louisiana's colleges and universities as a source of welleducated graduates as employees, a source of expertise for problem-solving, and a

source of technology for commercialization.

Goal Three: To have a standard of living among the top ten states in America and safe, healthy

communities where rich natural and cultural assets continue to make the State a unique

place, to live, work, visit, and do business.

Goal Four: Improve the public infrastructure of the region in order to support and sustain a viable

economy and environment.

Goal Five: Create and retain quality jobs and foster a more diversified economy.

The SCPDC Board of Directors acts as the Regional CEDS Committee. The staff of SCPDC remains in touch with local economic development committees and staff throughout the year through periodic attendance at local meetings and through a working committee of the region's economic development specialists. In this way SCPDC can provide support for local efforts and help move forward regional goals. Current membership lists for each of these committees is included in Appendix A.

1999-2000 ECONOMIC DEVELOPMENT ACTIVITIES

The goals set forth in this report illustrate the commitment of the South Central Region to achieve both a sustainable economy and environment. As mentioned in last year's report, a major theme repeated throughout the region in achieving these goals is the condition of transportation infrastructure. The lack of adequate surface transportation has been identified as a major hindrance to economic diversity. Several important regional efforts that began or continued during the past year will to improve regional transportation.

First is the designation of SCPDC as the Metropolitan Planning Organization for Terrebonne, Thibodaux and part of Lafourche Parish. This will greatly improve regional efforts to improve transportation by creating a regional forum for the prioritization of transportation projects and funding of improvements through federal and state means. Through the auspices of the MPO designation, SCPDC will be developing a Transportation Improvement Program and a Unified Work Program for Terrebonne and Lafourche Parishes and the city of Thibodaux. These two documents will help to prioritize planning and implementation efforts for highway and transit projects in the two parishes.

The second event is the funding of a Federal Highway Administration Transportation, Community and Sustainability Program grant for the River Parish Transit Authority. This project will develop a coordinated transit plan for the Parishes of St. Charles, St. James and St. John the Baptist. This project may well become a springboard for other collaborative efforts to improve transportation in the River Parish area. The Authority has been appointed and has had several preliminary organizational meetings. Work under the grant is expected to begin in July 2000.

Major infrastructure improvements are now underway that will improve access to and from the region. U. S. Highway 90 which traverses St. Charles, Lafourche, Terrebonne and Assumption is proposed for redesignation as Interstate 49. The State is constructing improvements to U. S. Highway 90 between Raceland and Des Allemands in order to improve traffic safety. The improvements include widening of the median and turning area and elevation of the roadway. Elevation of the roadway will improve the highway's ability to be maintained as an evacuation route during times of high water. Beyond the boundaries of the South Central District, the State is constructing other improvements to Hwy. 90, such as overpasses, that will bring the road up to interstate highway standards.

Completion of a north to south access road for the Veterans Memorial Mississippi River Bridge between Gramercy and Wallace will provide a major route linking the growing west and east bank communities of St. James and St. John the Baptist Parishes. The project will result in the creation of a new corridor that will eventually connect that Bridge to Highway 90 (the future I-49) in the Houma/Thibodaux area. The Environmental Impact Statement is now underway and alternatives for the proposed route are now under consideration.

Project planning for improvements to Louisiana Highway 1 has made progress. The feasibility study for highway improvements from Larose to U.S. 90 should be completed during the summer of 2000. An Environmental Impact Statement is underway for a critical stretch of highway between Port Fourchon and Golden Meadow. This portion of the highway is a vital commercial, recreational and hurricane

evacuation link and is extremely vulnerable to destruction as a result of erosion and land loss. Replacement of the Leeville Bridge with an overpass has been identified as a high priority for improvements to Highway 1.

In other transportation matters, the Houma-Terrebonne Airport Commission continues to make needed improvements to its runways and taxiways and to build additional aircraft parking and access roads. These improvements are necessary for the airport to maintain current cargo handlers and to be able to attract any additional tenants. The Commission received a grant from the EDA to install sewerage and a short roadway that will serve the East Ramp area of the airport. St. John the Baptist Parish completed a new 1,300 feet long taxiway during the past year. Future plans include the construction of additional hangars.

The region's three ports made progress in their ongoing infrastructure improvements. The Greater Lafourche Port Commission is working on plans for a major expansion at Port Fourchon encompassing 1700 acres. Phase I of the expansion is under construction and will provide approximately 5800 linear feet of additional bulkheaded waterfront and 150 acres of lease space at an estimated cost of \$13.8 million. The Port's location directly on the Gulf of Mexico and its central location to offshore oil and gas exploration activity has made it a prime location for onshore facilities and services related to petroleum exploration.

The Port of South Louisiana has begun a \$30 million improvement program with the installation of two cargo cranes at the general cargo dock. The addition will allow the Port to serve larger draft vessels and barges. Other phases of the program underway include the installation of mooring dolphins, access ramp and truck turning improvements and provision of an open lay-down storage area. In the coming year the Port plans to build transit sheds.

The Terrebonne Port Commission began the next phase of its improvement plan, actual dredging of a mile long slip off of the Houma Navigation Canal to be completed in approximately one year. Upon completion this will be a full service, shallow draft port facility serving the Houma Navigational Canal and Gulf Intracoastal Canal.

Another major event separate from transportation issues occurred during early 2000, the announcement that Nicholls State University will be the training camp location for the New Orleans Saints NFL football team. Improvements to the University campus and football facilities are underway so as to begin service in the summer of 2000. Terrebonne Parish is providing its new Civic Center as an alternate indoor facility in the event of bad weather. The location of the training camp in Thibodaux is expected to become an important factor in the local economy, generating \$2 million or more annually.

The Region's parishes and municipalities continued their individual efforts to sustain and attract new small businesses through a variety of programs. St. James opened its business incubator in an old hospital facility with the start-up of three small businesses. Terrebonne continued to operate its Revolving Loan Fund, as did SCPDC. The SCPDC approved one new loan during the past year and has one pending approval at this time.

Changes in the Region's Economic Conditions

The total estimated population for the South Central Region for July 1999 was 326,523, an increase of 5.7% over the 1990 population of 308,907. St. Charles Parish experienced the largest growth rate in the region and the 7th largest rate for the State between these two years at 12.18%. Overall employment has remained high although not quite as high as the same time last year. The Department of Labor unemployment rates for February 2000 and 1999 follow:

While most of the area faired well, St. James retained a comparatively high unemployment level. This may be tied to the seasonal nature of the primary agricultural crop, sugarcane, a mainstay in the economy of that parish. Another reason may be a plant closure. Agrico, a major employer in St. James Parish laid off 250 workers in 1999. New ownership at the facility may rehire a very small amount of workers. On the plus side CF Metals of Louisiana hired an additional 65 new employees.

In the Department of Labor's "Statewide Occupational Forecasting Focus Meetings Executive Summary" it was noted for the Assumption, Lafourche and Terrebonne area that medical services in general are strong and although shipyards are laying-off marginal jobs skilled workers are being hired. A need for high school apprenticeship programs for welder and fitters was foreseen.

In recent years, the South Central Region experienced substantial economic growth as the price of oil climbed and oil and gas exploration and production activity increased. However, changes during the past two years in the price per barrel of oil caused a slump in activity that eventually led to layoffs throughout Louisiana. However, the current oil downturn seems to be less drastic than that of the 1980's as evidenced by the still low unemployment rates.

Growth in industry and warehousing continues in the River Parish area. A 250,000 square foot warehouse is under construction in St. Charles and another 78,000 square foot warehouse was recently completed. Another developer is pursuing a potential warehousing and distribution center on the St. Charles West Bank near Killona.

Another growth sector of the economy is the shipbuilding and repair industry. Shipbuilding interests have diversified their clientele and thus are picking up many of the skilled workers laid off by more petroleum dependent concerns.

The Louisiana Department of Labor forecast of top demand occupations in the South Central District for the years 1996 to 2006 showed the four occupations with the highest annual percent of growth to be

systems analysts, home health aides, medical assistants and shipfitters. This is good news for the South Central Region as these sectors of the economy generally offer higher wages. The South Central Region has enjoyed excellent employment but still has lower that State and National per capita income levels.

Evaluation of Effectiveness in Meeting Goals

During the past year, EDA conducted a performance evaluation of SCPDC. Three recommendations were made as a result of that evaluation as follows:

- ♦ A clearer description of the areas of interest represented by individual Commission members is needed.
- ♦ District members and the general public should be better educated about the District's activities.
- ♦ There should be one designated EDA contact person who would devote at least 50% of his or her time to accomplishing the work program and being knowledgeable about EDA and other economic development programs.
- ♦ Reports filed under the District planning grant should describe specific activities and accomplishments in relation to the CEDS in order to clarify the District's strategic outlook. The current practice has been to report activities by community.

It was felt that these changes would improve the CEDS documents and create a more effective CEDS planning process while resulting in better developed EDA projects and better quality EDA applications.

The District has taken steps to follow-up on these recommendations by appointing its Chief Executive Officer as the EDA contact. The District staff is becoming more aware of informing both members and the general public of its activities through memorandum and media announcements. Future planning grant reports will be prepared in the recommended matter.

A review of the past year's activities and accomplishments was undertaken in partnership with the local economic development committees and regional CEDS task force. Comments and direction for improvements have been included in this report.

The region's emphasis continues to be diversification and stabilization of the economy, improvement of training and educational opportunities, creation of quality jobs and improvement of regional transportation.

WORK PLAN FOR 2000-2001

After review of the 1997 OEDP with the various local committees, task force and OEDP Committee, the following work plan was established for 2000-2001. These were determined based upon the identified CEDS goals, ongoing need in the various communities, and the current status of the local economies in relation to the EDA Reform Act of 1998.

Completion of new or upgrade of aging infrastructure, in particular those pertaining to transportation, remain a top priority for the South Central Region. Movement of goods and people within the region is a top concern. Improved transportation will help to move people to and from job centers and essential services and provide a much needed improved network for shipment of goods.

The creation of quality jobs remains an issue. Much of the South Central Region has maintained a high level of employment. However, per capita incomes remain well below the State and National averages. The Region hopes to attract the kind of industries and commercial activities that offer stable, higher paying wages. In order to accomplish this goal, emphasis is placed on improving the skills of the labor market, maintaining the quality of life and upgrading public services.

Continue efforts to gain support and funding for I-49.

Continue efforts to gain support and funding for improvements to La. Hwy. 1.

Continue preliminary design of La. 1 and La. 308 Couplet system in Thibodaux

Continue to develop and implement Safe Community Action Plan for the South Central Region to address ways to reduce traffic crashes.

Develop a transportation loop around Thibodaux.

Expand La. Hwy. 20 to a four-lane roadway in Thibodaux

Investigate feasibility of designating La. Highways 1 and 308 as alternate hurricane evacuation routes in Assumption Parish.

Monitor plans for creation of North to South Access Road between La. Hwy. 3127 and U.S. Hwy. 90.

Sewerage upgrade for Napoleonville.

Water system improvements in Lewistown, Lafourche Parish.

Complete sidewalk improvements throughout St. James Parish.

Construct West Bank Library Branch and relocate and construct larger LaPlace Library in St. John the Baptist Parish.

Continue efforts to create a Regional Criminalistics Laboratory.

Continue Regional Solid Waste Authority efforts to address solid waste disposal and transportation issues.

Continue working with the U. S. Corps of Engineers to improve the Attakapas Landing Boat Launch.

Develop a facility plan for Lafourche Parish Library.

Develop coordinated inter-parish transit service with the River Parish Transit Authority.

Develop design and engineering for a new Vacherie Branch Library and improvements to the Lutcher Library in St. James Parish.

Develop plan and design for St. Charles Civic Center/Fairgrounds.

Establish a neighborhood park in Baytree area and improve existing parks in St. James Parish.

Upgrade Fire Protection Facilities throughout the Region.

Create High Quality Jobs

Administration and expansion of SCPDC and Terrebonne Parish Revolving Loan Funds.

Continue Enterprise Zone Assistance

Continue regional economic diversification and new business recruitment efforts.

Create a technology based business incubator center in Thibodaux.

Create a business incubator in Terrebonne Parish.

Develop warehousing, light industrial and high technology clusters in St. Charles Parish. Investigate feasibility of a warehouse distribution center in St. John the Baptist Parish. Operation of St. James Parish Incubator program.

Mr. Hymel introduced the corporate sponsors, Mr. Rickie Pitre and Mr. Mike Guidry of SLECA.

Acceptance of Minutes of June 23, 1999 Regular Meeting

A motion was made by Mr. Bonvillain, seconded by Mr. Bailey to accept the minutes of September 23, 1999. There being no opposition, the motion passed unanimously.

Review and Approve FY 1999-2000 Budget Adjustments

Mr. Belanger stated that since the last meeting the agency was able to obtain several other grants/contracts, which increased the amount of revenues to \$167,764.00. He stated that the budget was amended to reflect the increase in revenues. He stated that the agency has allocated for 5% salary increases. He said that as of this date, the agency has an excess of \$3,501.00 in this year's budget.

A motion was made by Mr. Bailey, seconded by Mr. Sylvester to approve the FY 99-2000 budget adjustments. There being no opposition, the motion passed unanimously.

Presentation of FY 1998-99 Audit by Bourgeois Bennett, LLC

Mr. Belanger introduced Ms. Deanna Zeringue and Ms. Michelle Gautreaux of Bourgeois Bennett, LLC. Ms. Zeringue presented the FY 1998-99 audit to the Board and she highlighted

the most important areas. She stated that the independent auditor's report states that the agency has an unqualified or clean opinion, which is the best opinion that is given.

A motion was made by Mr. Bailey, seconded by Mr. Bonvillain to accept the FY 1998-1999 audit report. There being no opposition, the motion passed unanimously.

Amendment to Personnel Policies and Administrative Manual

Mr. Belanger stated that the agency was awarded a grant from the Louisiana Highway Safety Commission, which requires that the agency Personnel Policies Manual be amended to include the following language regarding the Hatch Act:

"Any employee of the SCPDC whose salaries are financed by Federal Government grants or loans may not be candidates for public office in partisan elections or use their positions with the SCPDC to influence public elections. A member of the SCPDC staff shall refrain from coercing other agency employees into making political contributions."

Also it is required that the Administrative Manual be amended to include the following:

"Whenever in the course of travel for purposes related to their employment, employees and their passengers shall use seat belts."

A motion was made by Mr. Bonvillain, seconded by Mr. Bailey to approve the amendments to the Personnel Policies and Administrative Manual. There being no opposition, the motion passed unanimously.

Status Report of SCPDC Building Project

Mr. Belanger stated that there have been discussions with Rep. Dupre, Rep. Hunt Downer, and Senator Mike Robichaux. He said that he has asked Rep. Dupre to come here to enlighten us on the progress that has occurred in regards to the highway department taking over the property that Mr. Donald Rouse owns.

Rep. Dupre stated that about three (3) weeks ago he had a meeting with Speaker Hunt Downer and Dr. Kam Movassaghi in Baton Rouge. He said that one of the topics discussed was about trying to move forward with having a DOTD district in Gray, Louisiana for primarily Terrebonne, Lafourche, and possibly Assumption and St. Mary Parishes. He said that Dr. Movassaghi is fully on board with the idea, but this will take a phase in process to complete. He said that the first phase was to buy the old Delta College building, which was done last year. The second phase will be to do the capital improvements for the other maintenance buildings, fencing, etc. The last phase will be the actual funding and the staffing to upgrade the Houma sub-district into a full DOTD district. Rep. Dupre stated that there are three pieces of property on the 22-acre tract. He stated that he and Speaker Downer would like to eventually put the entire 22 acres under the State umbrella and make it a State complex. He stated that several years ago the Department of Transportation purchased 8 1/2 acres of property on the corner of Coteau and Park and has had the property appraised. He said that there have been some negotiations with Donald Rouse regarding a property swap of the Coteau/West Park property and the property in front of the Delta College building in Gray. The difference in price was only \$3,000.00 on the two appraisals. He said that if Mr. Rouse is interested he could pay the State \$3,000.00 and get the 8-1/2 acres of property on the corner of Coteau and West Park. Mr. Dupre stated that on September 8, 1999, Mr. Rouse accepted the offer. He said that the title has not transferred yet, but should very shortly. He said that the empty piece of property would be the location that will be recommended to place the new SCPDC building.

Agency Activity Report

Mr. Belanger briefly discussed the Agency Activity Report, which includes all activity by the agency since the June 23, 1999 meeting.

The New Regionalism Plan of New Orleans

Mr. Belanger stated that Metrovision and downtown New Orleans entrepreneurs have realized that New Orleans is in a crunch for taxes, etc. and are trying to find out how to stop the flight out of New Orleans. He said that they have contracted with a person named David Rusk who is an Urban Planner, past federal representative, and Mayor of Albuquerque NM. Mr. Rusk identified in the plan that the three river parishes that SCPDC currently represents should be made a part of this new regional planning commission that would be mainly made up of the New Orleans area. Mr. Belanger stated that it also identifies growth development standards, which means that the committee could have the ability to be able to place build out restrictions. He said that the committee will also look at the river parishes land use and existing zoning patterns to be able to say where and what type of zoning should occur, and this could take away from the local planning commissions ability to be able to regulate within their own areas. Mr. Belanger stated that one of the problems that the Regional Planning Commission of New Orleans has always found is that they have never done a lot of soft planning (EDA Applications, CDBG Projects, etc.)., but has focused on transportation issues over the last 20 years, which they have done quite well. He said that the organization that is pushing this New Regionalism Plan is saying that these things have not been attended to. He said that South Central Planning has made great leaps and bounds of collaborating with Regional Planning Commission over the last year. Mr. Belanger said that he and Mr. Walter Brooks of RPC would like to put together a joint meeting between SCPDC and RPC to talk about transportation issues, environmental issues, and development issues that overlap one another to see if there are some things that could be worked on jointly.

Mr. Hymel stated that Mr. Belanger has the Board's authority to go to the meetings regarding the New Regionalism so that he may keep them on top of everything regarding this matter.

Census Complete Count Committee

Mr. Wayne Thibodeaux was to make a presentation regarding the complete count committee but was not present for the meeting. Mr. Bonvillain stated the importance of having a total count. He said that the national figure is \$150.00 per person in state and federal dollars and if you miscount 1000 people in a 10-year period you would be looking at 1.5 million dollars. Mr. Bonvillain stated that Mr. Thibodeaux represents the Census Bureau for most of the parishes in the South Central Planning region.

Mr. Belanger stated that South Central Planning would act as a facilitator for the Complete Count Committee in Terrebonne Parish. He said that the agency is currently sending out

meeting notices to try to get the clergy, media, education system, and public/private organizations involved in getting the message out of how important the census is.

Mr. Belanger stated that he would get with Mr. Thibodeaux to get all of the information regarding the Complete Count Committee, and get a sample of the resolution that Terrebonne Parish passed to send to all of the parishes and towns.

Mr. Hymel also pointed out the importance of the Census for use with the reapportionment, which will be occurring shortly.

Presentation by Ms. Pam Roussel on Nonpoint Source Pollution

Mr. Kevin Belanger introduced Mr. Andrew Barron of DEQ and Ms. Pam Roussel, Project Manager, South Central Planning and Development Commission. Mr. Barron is the liasion at DEQ who Ms. Roussel frequently works with in preparing the Nonpoint Source Pollution presentations.

Ms. Roussel stated that the agency has made over 142 classroom presentations reaching 3,492 children. She said that in updating the database of schools in the six (6) parish region there is a total of 147 schools.

Ms. Roussel presented the adult presentation on Nonpoint Source Pollution to the Board.

Corporate Sponsor Presentation

Mr. Hymel introduced the corporate sponsor, Mr. Mike Guidry and Mr. Ricky Pitre of SLECA. Mr. Guidry spoke briefly about the organization.

Other Business

Letter of Engagement - Bourgeois Bennett, LLC

Ms. Elizabeth Breaux stated that the agency has used Bourgeois Bennett for many years. She said that the agency has always worked well with Bourgeois Bennett. She said that three years ago we signed a three-year engagement letter for \$14,000.00 a year, which Bourgeois Bennett is again presenting.

A motion was made by Mr. Bailey, seconded by Mayor Townsend to accept the three-year engagement of Bourgeois Bennett, LLC. There being no opposition, the motion passed unanimously.

There being no further business to discuss, a motion was made by Mayor Townsend, seconded by Mr. Bailey to Adjourn. There being no opposition, the motion passed unanimously .

Mr. Hymel opened nominations for Vice-Chairman. A motion was made to nominate Edmond J. Blanchard, III by Mr. Willis Henry. Mr. Laque seconded the motion. There being no opposition or other nominations, Edmond J. Blanchard, III was elected unanimously as Vice-Chairman.

There being no other nominations, Mr. Sylvester made a motion, seconded by Mr. Laque to close nominations and that everyone be elected by acclamation.

Resolution in Dedication to Ms. Elizabeth Breaux

Mr. Belanger stated that Ms. Elizabeth Breaux recently left the agency on good terms. He said that he would like to issue her a resolution in regards to the appreciation of the time that she worked for the agency.

A motion was made by Mayor Townsend, seconded by Mr. Henry to approve the resolution in dedication to Ms. Breaux. There being no opposition, the motion passed unanimously.

Resolution Authorizing Kevin Belanger and Julie Boudreaux Access and Control Over Safety Deposit Box

Mr. Hymel explained that the resolution is necessary due to Ms. Breaux being replaced by Ms. Boudreaux. A motion was made by Mr. Laque, seconded by Mr. Ingram to approve the resolution. There being no opposition, the motion passed unanimously.

Resolution: Establishment of the Southeastern Louisiana Regional Planning Council

Mr. Hymel explained that the resolution is to establish a cooperative endeavor agreement between South Central Planning and Development Commission (SCPDC) and Region Planning Commission (RPC). He said that this resolution would mandate that the two commissions meet jointly twice a year. Mr. Hymel said that there has been some talk for about a year and a half that some parishes may pull out of SCPDC to join RPC or vice versa. He said that he believed that this is a step forward to try to keep this from happening.

A motion was made by Mr. Sylvester, seconded by Mr. Ingram to adopt the resolution establishing the Southeastern Louisiana Regional Planning Council. There being no opposition, the motion passed unanimously.

EDA Performance Evaluation

Mr. Belanger stated that South Central Planning and Development was one of two planning districts in the State of Louisiana to be evaluated by EDA. He said that the report from the review is very positive. He stated that one of the areas noted in the review is that SCPDC operates on only 30% reoccurring revenues.

Mr. Hymel asked Mr. Belanger what were some of his ideas to bring in more revenue to the Commission. Mr. Belanger stated that of the eight planning districts in the State of Louisiana, all with the exception of SCPDC operate with at least 90% reoccurring revenues. Mr. Belanger stated that he has been pursing the possibility of SCPDC becoming the Metropolitan Planning Organization (MPO). He said that presently Houma is the designated MPO for strictly Terrebonne Parish. He said that the agency has the ability to expand the area to include parts of Lafourche and all of Thibodaux. He said that because it meets the population threshold, the State and the Federal Government will allow this to take place. Mr. Belanger stated that SCPDC becoming the MPO would give the agency the needed credibility to be able to pursue federal and state highway projects. Mr. Willis Henry stated that it is time that parishes begin to think regionally and this move is a step in that direction.

Status Report on SCPDC Property/Building Project

Mr. Belanger briefly updated the board on the status of the SCPDC building. He is currently working on a Capital Outlay Request and a joint use agreement with the LA DOTD.

Amendment to Personnel Policies

A motion was made by Mayor Townsend, seconded by Mr. Laque to amend the SCPDC personnel policies to include Martin Luther King Day as a paid holiday for all full time, permanent employees.

Agency Activity Report

Mr. Belanger briefly discussed the Agency Activity Report which includes all activity by the agency since the September 23, 1999 meeting.

Corporate Sponsor Presentation

Mr. Dale Hymel introduced the Corporate Sponsor, Mr. Steve Nosacka of Holley, Tucker, Bossier and Nosacka. Mr. Nosacka informed the Board of some of the activities his agency handles.

There being no further business to discuss, a motion was made by Mr. Sylvester, seconded by Mr. Ingram to adjourn. There being no opposition, the motion passed unanimously.

Review Financial Statement Ending February 29, 2000.

Mr. Belanger stated that there are two separate budgets in the packets. He said that one copy includes the RLF money and the other does not. He explained that the reason for the separation is that the Revolving Loan Fund shows an additional \$700,000.00 in the bank, which may be misleading.

Mr. Belanger stated that as of February 29, 2000, the agency had total assets valued at \$582,982.89, total liabilities of \$153,640.63, a total fund equity of \$429,342.26, and a total liabilities and fund equity of \$582.982.89. He also stated that the agency has a year to date total revenues of \$315,021.89, total expenditures of \$281,465.30, which gives an excess balance of \$33,556.59. He said that the projected fund balance is \$345,715.82.

A motion was made by Debbie Dufresne Vial, seconded by Alvin Sylvester to approve the financial statement ending February 29, 2000. There being no opposition, the motion passed unanimously.

Discussion of SCPDC By-laws, Article 3 - Membership, Paragraph 3.6 in regards to minority representation.

Mr. Belanger explained that in early January he provided all of the Parish Presidents with the procedures as to nominating a private and minority representative to the South Central Planning Board of Commissioners. He further explained that Terrebonne Parish subsequently nominated a white woman to the minority seat, which was then contested by the NAACP. He said that Jerome Boykin of the NAACP reviewed the Commission's By-laws in which he noted some discrepancy as to the term and the meaning of minority community. Mr. Belanger stated that over the last three (3) months Terrebonne Parish has requested his attendance at their meetings to give them a legal understanding and definition of what is construed to be minority community. Mr. Belanger stated that he has corresponded with Mr. Alfred Garcia of EDA to get an interpretation of what EDA deems minority community. He said that Mr. Garcia's interpretation of minority is either a Black, Hispanic, American Indian or Asian Islander. Mr. Garcia has also given examples as to how to find minority representation if a Parish Council cannot find a representative of that nature. Mr. Belanger said that Terrebonne Parish Consolidated Government is asking South Central Planning for an interpretation of the agency's By-laws, because the Parish Council felt that a woman could be considered a minority.

Mr. Belanger stated that in St. Charles Parish a woman was nominated to the minority seat. He said that he did not feel he could make the decision of not allowing the person to be appointed to the Commission. He asked the Board for their guidance on this issue.

Mr. Bergeron stated that room should be made in the appointing guidelines for someone from the minority community to have a voice. He believes that there is no way that the term minority community could be misinterpreted to mean a woman holding the appointment. He explained that there was conflict among the Council members at the time the appointment was made. He said he believes that room should be made for both minority and women on the Board. He also said that he thinks that there should be specifics, without any question, for a person who lives in a minority community to be able to serve on the Board, but at the same time within the region,

it should be mandated that an elected woman be represented. He said that he sympathizes with both sides, but felt it would be a step backward for the Board to deny an elected individual from the minority community from serving on the Board.

Mr. Belanger stated that in the course of speaking with EDA officials, he has come up with some suggested verbiage that could be included into our By-laws. The verbiage is as follows:

This statement could be added to the existing verbiage: "In making other appointments, appointing authorities are encouraged to consider the representation of women and the interest of the business, industry, and banking community."

This statement could replace the existing verbiage: "Parish Councils are encouraged to appoint elected Minority Community Representatives, or representatives in accordance with EDA guidelines. However, they can appoint other members, but will be rejected by the Board when such makeup is not satisfactory to the Economic Development Administration."

Mr. Belanger explained that the situation in St. Charles Parish is different. He stated that the only minority person on the Council decided not to be a part of our Commission. He said that Dee Abadie, the only woman on the council, was chosen to be the appointee. He said that as CEO of the Commission, he does not feel that he could deny her nomination to the Commission. He asked the Board to give some consideration to instances such as this.

Mr. Belanger stated that EDA is concerned with the overall representation. He said that if there is 25% minority representation on the Board, it should be equal to the total population of minorities in the region.

Ms. Pamela Ehlers of EDA stated that Terrebonne Parish has the largest minority population, so you would think that Terrebonne Parish should have a minority representative. Ms. Ehlers stated that EDA encourages female, handicapped, unemployed and underemployed to be represented on the Board. She said that if this is not possible with the current election, then EDA would suggest that the Board either look at adding a member from each parish, or maybe a couple of at-large representatives targeted toward a particular group that may be missing.

Mayor Townsend suggested creating a subcommittee to come up with the exact wording for the by-laws or to possibly create an at-large position.

Mr. Wayne Thibodaux explained that the Terrebonne Parish Council voted four (4) to three (3) to allow a white female to take the seat based on the by-laws. He explained that the Articles of Incorporation of SCPDC is clear. The Articles of Incorporation state that representation shall be determined in a manner prescribed by the by-laws. He said that as he looked at the three (3) ways in which to seat people on the Board, there was a third person, as a private citizen, that could have been a white female or any race or sex depending on the Chief Elected Official's choice. Mr. Thibodaux stated that he has no problems with the by-laws, but felt that we should ensure that women be a part of the process. Mr. Thibodaux said that the by-laws states "a representative of the minority community" and he believes that it needs to be taken together in

that context, and in his mind the four that voted for the white female were in error. He asked that the board ensure that each Parish has a chance to put a minority representative on the Board.

Mr. Laque said that in St. Charles Parish the one minority representative that is on the Council refused the seat on the SCPDC Board. Mr. Thibodaux replied that in that case the woman should have been offered the seat, and that he is happy that she was offered the seat. He felt that was an acceptable process. He further stated that if he would have not wanted the seat, he would have been fine with the appointment of the white female.

Mr. Blanchard said that he thinks that the problem lies with the definition of minority community and not the representative. He said that there is a need to set up a subcommittee to address some things within the by-laws. He said that as a Board we do not govern how the Parishes make their decision. He said that we need to get something to the Council that will give them clearer direction as to what SCPDC needs appointment wise.

Ms. Abadie asked if there was ever any female representation on the Board before. She said that if our objective is inclusion and not exclusion, you are missing out on a great segment. She said that she has worked in oil and gas for many years and that she is a minority. She said unfortunately the definition does not say that, but lack of women's input is not diversity. She explained that there is a minority person on the St. Charles Council, but he couldn't make the day meetings and decided that he wanted to take the Housing Authority. She said that certainly the minority community is absolutely important, but please don't lose out on the diversity of the inclusion that the agency could have from women of any race.

A motion was made by Mr. Sylvester, seconded by Mr. Laque to adopt the definition of minority representation as that which is outlined and defined by EDA (Black, American Indian, Asian or Pacific Islander, or Hispanic). The motion also gives Mr. Belanger the authority to go before the Terrebonne Parish Council to say that this is the definition that should be followed when making an appointment for the minority seat. There being no opposition, the motion passed unanimously.

As suggested by Mayor Townsend, Mr. Hymel agreed to create a subcommittee to look at amending the By-laws of South Central Planning to encourage the participation of women on the South Central Planning Board. Those who will serve on the subcommittee are Ed Blanchard as Chairman, Dale Hymel, Jr., Kevin Belanger, Jerome Boykin, Dee Abadie, Alvin Sylvester, and a representative of EDA.

Ms. Lafont said that the problem may lie with the minority representative having to be an elected official. Mr. Blanchard replied that it is one of the matters the subcommittee needs to review.

A motion was made by Mayor Townsend, seconded by Ms. Lafont to form a subcommittee to review the by-laws. There being no opposition, the motion passed unanimously.

Discussion of Metropolitan Planning Organization (MPO) Expansion

Mr. Belanger stated that the resolutions between Terrebonne, Lafourche and the City of Thibodaux are all signed, agreeing to include all of the City of Thibodaux and the periphery around Thibodaux into the Metropolitan Planning Organization. He said that the signed resolutions have been packaged along with a request to the LA Department of Transportation to allow South Central Planning to become the technical staff for the MPO. He said that he received a request from the La DOTD to formally put together an agreement to be signed by the Parishes of Terrebonne and Lafourche and also the City of Thibodaux.

Status report on SCPDC Property/Building Project

Mr. Belanger stated that the agency submitted a Capital Outlay Request. He said that hopefully we will get some money this year to help finish the accruing of all of the money needed to complete the building. He said that the agency roughly needs about \$820,000.00 for the remaining funds. DOTD has purchased the property necessary for the SCPDC building, which is located on the Delta College site in Gray, LA. He explained that the Joint Usage Agreement cannot be completed until we know the actual date that we will be occupying the property.

Mr. Belanger said that he has discussed with Mr. John Evanco the possibility of an interim move from the agency's existing building to the Delta College facility, which now houses LA DOTD offices. He explained that with SCPDC becoming the MPO, there will be a need for more space than currently occupied.

Mr. Belanger explained that the Executive Committee will work to facilitate this move. Mr. Sylvester asked Mr. Belanger if there will be a rent agreement. Mr. Belanger replied that there would be a rent agreement. He said that SCPDC will probably pay a little less than the \$1,600 currently paid.

Rep. Dupre suggested that during the first week of the regular session, Kevin, the Chairman and a couple of the Parish Presidents set up a meeting with Mark Drennan regarding the Capital Outlay Bill.

Rep. Faucheux asked Mr. Belanger if he had submitted the Capital Outlay Request by the November 1 deadline. Mr. Belanger replied that SCPDC had submitted later, but were told that it would be accepted. Rep. Faucheux said that it may be accepted by the Committee, but the Division of Administration will try to knock out all of the ones that were not timely submitted.

Solid Waste Authority

Rep. Dupre stated that Act 982 is enabling legislation, it is not mandatory He said that up to seven Parishes can join together to create the solid waste district. (Assumption, Lafourche, St. Charles, St. James, St. John the Baptist, St. Mary, and Terrebonne) He explained that at least two Parishes must pass ordinances by July 1, 2000 to create the district or the bill will dissolve. He explained that each parish will have two (2) appointments. If there are municipalities within the Parish with separate governing authorities, then those municipalities can also join in for their solid waste needs. One of the two appointments will be a municipal appointment if there are municipalities participating within the Parish.

Rep. Dupre said that next year the bill may need to be tweaked a bit. He said that one suggestion he has is to allow all of the chambers and industrial associations within the parishes participating in the district to submit nominations to the Governor so that there will be one at-large member from the whole general district. He said that by creating the district the Parishes are not obligating any resources now. They can wait two (2) to three (3) years if they have to. A Parish can back out by ordinance if no debt is incurred, but once debt is incurred and the Parish is a part of the District, they are obligated to pay their share. Mr. Belanger pointed out that the two parishes need to be contiguous.

Rep. Dupre said that after the District is created, he would suggest that South Central Planning be the informal administrator of the District until there is some kind of funding source.

There being no further business to discuss, a motion was made by Mayor Townsend, seconded by Mayor St. Pierre to adjourn. There being no opposition, the motion passed unanimously.
