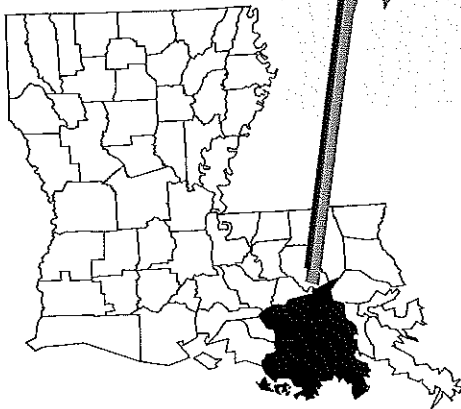

## ***Introduction***

## INTRODUCTION

The South Central Planning and Development Commission (SCPDC) prepared an Overall Economic Development Plan (OEDP) in 1997 and subsequently prepared an annual update to it in 1998. That OEDP was prepared in accordance with guidance of the Economic Development Administration (EDA). It provided an overall picture of the six parish regional economy and strategies for attaining goals spelled out in the plan. In 1998 Congress enacted the EDA Reform Act changing the landmark OEDP process to the new Comprehensive Economic Development Strategy (CEDS). The CEDS process has much in common with its predecessor, it will be completely updated every five years and annual updates are prepared in the interim documenting progress on economic development activities undertaken in the region and reporting changing economic development conditions. While the Reform Act requires the approved CEDS in order to obtain further funding assistance through the EDA, the value of the process for economic development practitioners and planners should not be overlooked.

The Reform Act set as its objectives the creation of jobs, the fostering of more stable and diversified economies, and improved living conditions. The CEDS will thus be a mechanism for coordinating the efforts of those concerned with economic development. The CEDS will comprise four main elements, *analysis, vision, action plan, and evaluation*. The *strategy* analyzes the regional economy and looks at external trends and forces. It identifies partners and resources for economic development. The *vision* is a statement of the region's goals; "Where do we want to be?" An *action plan* is developed as a way to attain the goals. Finally, an ongoing *evaluation* of the CEDS is made to determine what improvements or changes should be made in the strategy.

The SCPDC 1997 Overall Economic Development Plan covered much of the content required by the new CEDS format. New to the CEDS program will be standards for evaluation. This 1999 Annual Report will be presented in a fashion to act as a transition between the OEDP and the CEDS. Thus it will contain features common to both and will provide an evaluation process for this and forthcoming years. The report is divided into the following sections.

1. *Adjustments to the CEDS.* Adjustments are made to the implementation strategy outlined in 1997 to account for unforeseen opportunities or unexpected problems. Changes in the structure or composition of the CEDS (OEDP) committees are reported.
2. *Report on the previous year's economic development activities and any significant changes in the region's economic conditions.* Activities undertaken in the previous year are documented in relation to the needs and objectives identified in the 1997 strategy and the objectives of the 1998 Reform Act.
3. *Annual Evaluation.* A proposed guide for evaluation of the effectiveness of the CEDS in meeting goals and objectives is provided.
4. *Next Year's Goals.* A program of achievable activities for the upcoming year is provided. A brief discussion is provided for each in order to show how it is related to the goals and objectives of the 1997 OEDP and the 1998 Act.

The State of Louisiana has also set new goals for economic development. Louisiana 2020 Goals has three goals that mirror those of the 1998 Reform Act.

- *Goal One: To be a Learning Enterprise in which all business, institutions, and citizens are actively engaged in the pursuit of knowledge, and where that knowledge is deployed to improve the competitiveness of businesses, the efficiency of governmental institutions, and the quality of life of citizens.*
- *Goal Two: To have an economy driven by a diverse and thriving set of technology-intensive industries that actively utilize Louisiana's colleges and universities as a source of well-educated graduates as employees, a source of expertise for problem-solving, and a source of technology for commercialization.*
- *Goal Three: To have a standard of living among the top ten states in America and safe, healthy communities where rich natural and cultural assets continue to make the State a unique place, to live, work, visit, and do business.*

In developing and refining goals and objectives, the SCPDC remains cognizant of those established by the EDA and State.

## ***Adjustments to the 1997 OEDP***

## ADJUSTMENTS TO THE 1997 OEDP

A minor adjustment was made in the presentation of the 1997 OEDP goals to better illustrate how the South Central Region goals compare to those of the Reform Act and Louisiana 2020.

The strategy for implementation of the 1997 OEDP was outlined in stated objectives for each goal. A list of programs and projects was then provided on a regional and parish basis. Responsibility for implementation was noted. The strategy for implementation will remain the same. There will be some projects better suited for local implementation and those that the regional economic development district is better suited to handle. Some projects or programs are actually being conducted under the auspices of other local, state or federal agencies or private concerns. These are identified and tracked regardless of the implementing concern because of their importance to and support by SCPDC and its member communities.

The structure of the CEDS committee will be the same as that for the OEDP. Three of the individual parishes have active local Economic Development Committees. SCPDC will remain in touch with the local committees through their parish representatives and periodic attendance at meetings. Input from the committees will be obtained in setting the goals and implementation strategies. In parishes without active committees, SCPDC will work with the appointed Parish staff and other groups, such as chamber of commerce, port commissions, etc., to obtain information necessary for the development of the CEDS.

A regional task force composed of members of these local committees and staffs acts as a working group to help the SCPDC staff prepare and update the CEDS. In this manner, SCPDC ensures it is addressing the concerns and priorities of each member community. Finally the SCPDC Board of Directors acts as the Regional CEDS Committee giving final review and approval to the comprehensive strategy prior to submission to EDA.

Current membership lists for each of these committees is included in Appendix A.

## ***Economic Development Activities***

## 1998-99 ECONOMIC DEVELOPMENT ACTIVITIES

The goals set forth in the 1997 OEDP illustrate the commitment of the South Central Region to achieve both a sustainable economy and environment. One issue at the forefront in reaching these goals is the condition of transportation infrastructure. A summation of major steps in addressing these the problem follows.

The lack of adequate surface transportation has been identified as a major hindrance to economic diversity. During the past years great effort has been made toward improvement of major transportation routes throughout the region. The success of these efforts is about to reached fruition with the completion of a four-lane U. S. Highway 90 from I-310 in St. Charles Parish westward to Lafayette. Groups and individuals of the region have joined with those communities to the west in an organized effort to obtain interstate status for the new U. S. Highway 90. The efforts of these groups have resulted in support by the State Governor as apparent from the "FUTURE I-49 CORRIDOR" signs dotting the highway. The closure of a two-mile stretch of Highway 90 between Raceland and Bayou Des Allemands following three tropical storms focused attention on the need for highway improvements in the region. The result was a commitment from the State to elevate that section of roadway in order to secure it during evacuation situations and ensure ongoing commerce under normal circumstances.

Another major project is the completion of a north to south access road for the Veterans Memorial Mississippi River Bridge between Gramercy and Wallace. This route will link the growing west and east bank communities of St. James and St. John the Baptist Parishes. The region is monitoring State plans for the creation of this new corridor that will eventually connect that Bridge to Highway 90 in the Houma/Thibodaux area. The corridor study is complete and several alternative routes are being considered. Regardless of the route chosen the road will traverse an environmentally sensitive area and its design will have to be one compatible with the land.

Another major infrastructure project underway involves the LA 1 Corridor. Numerous initiatives are ongoing on this corridor. Congress authorized in its TEA 21 legislation, over \$6 million for LA 1 under its high priority funding. The Governor created the Louisiana Highway 1 Project Task Force by Executive Order MJF 98-46, which is charged with recommending highway improvements from Port Fourchon to Alexandria along the LA 1 Corridor. the LA 1 Coalition, a Coalition of private and public stake holders in support of highway improvements from Port Fourchon to U.S. 90 has been successful in conducting a toll road study from Port Fourchon to Golden Meadow, and along with the DOTD is conducting an Environmental Impact Statement for a proposed elevated highway in this reach. A feasibility study for highway improvements from Larose to U.S. 90 is also underway. Stretches of this vital commercial, recreational and hurricane evacuation link are extremely vulnerable to destruction as a result of erosion and land loss. The recent explosion in deepwater oil and gas activity has resulted in unprecedented growth of Port Fourchon and greatly increased its significance as an intermodal facility for support of this nation's energy needs. State of the art facilities such as "C Port" located at Port Fourchon have revolutionized servicing of oil field needs.

In other transportation matters, the Houma-Terrebonne Airport Commission is seeking FAA assistance to improve its runways and taxiways and to build additional aircraft parking and access roads. These improvements are necessary for the airport to maintain current cargo handlers and to be able to attract any additional tenants. St. John the Baptist Parish has taken steps to review and prioritize needs at its Parish airport. The Parish is requesting FAA assistance for construction of a taxiway that will improve safety for airport users.

The region's three ports made progress in their ongoing infrastructure improvements. Port Fourchon announced in February 1999 the completion of a new deep draft berthing facility capable of accomodating the new generation of deepwater support vessels. A new operation building was also completed in early 1999. An \$11 million E-slip Project is now underway and a 650 acre expansion project is being planned. The Port of South Louisiana completed a master plan that will guide future decisions regarding improvements to the Globalplex facility. Plans include expansion of docking facilities, and transit sheds, installation of upstream mooring dolphins and upgrade of additional railroad facilities. In the immediate future, the Port plans to expand its promotion campaign and marketing of industrial sites in its service area. Construction of a waterline that will improve water pressure and flow throughout Globalplex facility will be completed in the very near future.

The Terrebonne Port Commission completed Phase I, site preparation, of its plans for creation of a mile long slip off of the Houma Navigation Canal. The next phase, actual dredging of the slip is expected to begin in July 1999 and be completed in approximately one year. Upon completion this will be a full service, shallow draft port facility serving the Houma Navigational Canal and Gulf Intracoastal Canal.

The Three River Parishes have united in order to improve public transit service between the river communities. The Parishes plan to establish a transit authority whose goal will be the interfacing of existing parish transit operations in order to move passengers from one end of the region to the other. In this way residents of the parishes will have improved access to jobs and services. St. James Parish now operates the only rural parish route deviation/demand response system in Louisiana, providing about 2,000 passenger trips per month. The system added a new route in 1998 that crosses the Veterans Memorial Bridge. The Terrebonne Parish Good Earth Transit Operation is planning to extend a route to Thibodaux that will serve the Nicholls State University campus and the Thibodaux Regional Hospital. Provision of these transit services offer improved access to jobs and service locations while reducing automobile emissions and thus help improve the overall quality of life.

The Association of Levee Boards of Louisiana has put forth a plan to address comprehensive hurricane protection planning for all of South Louisiana. Endorsed by the region's communities, such an effort will include evacuation route protection, coastal marsh and island enhancement and comprehensive approaches to interior drainage. This comprehensive approach to hurricane protection will rely heavily on regional planning and cooperation.

Knowing that good infrastructure alone will not ensure economic development; the region set other goals designed to improve and better market often overlooked segments of the economy. One of these is tourism. The region's potential in this area is untapped. Those that enjoy the outdoors

are drawn to the area for its natural beauty and outdoor recreational opportunities. The Barataria Terrebonne National Estuary Program is investigating ways to promote nature based tourism in the region. History buffs can visit the early settlements and sites that played important roles in Louisiana and United States history. The St. James Cultural and Heritage Center in Litcher noted more tourists than usual during the past year including larger numbers of guided tours. The recently created Mississippi River Corridor Commission plans to promote the historic and scenic values of the River and the communities that developed along its banks.

Terrebonne Parish continued its efforts to establish a business incubator system to bolster small businesses. The SCPDC submitted a grant request to the EPA for the creation of an inventory of brownfield sites in the region. Another application, through the OSHA Susan Harwood Program, will allow SCPDC to offer OSHA training programs for the shipbuilding industry. The SCPDC was successful in loaning funds through its Revolving Loan Fund to help two businesses in the past year.

Finally, the District continues to strive to resolve the conflicts between development and quality of life by seeking to attract those industries that are sensitive to the surrounding environment and culture. Foremost among these efforts are those of the Barataria Terrebonne National Estuary Program whose territory is nearly coterminous with that of the SCPDC. The program has established a management plan through the efforts of a multitude of residents and agencies of the South Central Region. SCPDC seeks to work with BTNEP in order to improve and sustain the natural environment of the Region. With funding from the Louisiana Department of Environmental Quality, SCPDC has been able to augment the programs initiated by BTNEP by providing an educational outreach program in area schools that illustrates how nonpoint source pollution effects the quality of water. The quality of water in the estuary has been identified in four of the seven problems that the BTNEP management plan seeks to correct.

## ***Accomplishments***

## ACCOMPLISHMENTS

*Changes in the Region's Economic Conditions*

In recent years, the South Central Region experienced substantial economic growth as the price of oil climbed and oil and gas exploration and production activity increased. However, changes during the past year in the price per barrel of oil caused a slump in activity that eventually led to layoffs throughout Louisiana. The change was brought about as a result of a glut of oil and stagnant demand. Layoff announcements came from several major oil and gas producers including Amoco, Chevron, Exxon, Mobil, Shell and Texaco. Many jobs were eliminated in the New Orleans metropolitan region. Some of the layoff events are due to mergers and company buyouts as oil related businesses seek to preserve their stance in the wake of fluctuating industry cycles. Industries in the South Central region that serve the oil and gas producers announced their own layoffs and buyouts as a result including Baker-Hughes, McDermott, and Gulf Island Fabricators.

Industrial growth has continued in the River Parish area. A new plant was completed by Epsilon Products Co. near Garyville to produce polypropylene resin. The plant will employ approximately 100 people.

However, economic experts believe that the impact of this decline will not be as severe as in the 1980s as the price of natural gas has not decreased and new technology allows exploration in deeper water areas formerly not accessible. Nicholls State University economist Dr. Morris Coates was quoted in the 1/26/99 Daily Comet as noting the economy has absorbed the effects much better than in the early 1980s when the low oil prices devastated the regions economy. Thus far

only 1% of the jobs have been lost. He noted more diversification in the local economy and strong employment in other areas, such as the shipbuilding industry.

Many agree that steps taken after the bust of the mid-1980's to diversify and become less reliant on one industry will help to prevent the major economic losses felt a mere decade ago. Retail growth, medical services and transportation services continue to attract spin-off businesses to the Houma/Thibodaux area.

The River Region continues to experience steady growth related to industries attracted to River frontage for both transportation reasons and the ready supply of water necessary for their processes. With the completion of the latest bridge crossing and new highways, suburban growth outward from New Orleans, and possibly Baton Rouge, will no doubt continue. The announcement of a major new subdivision containing 2000 residential lots near the Hale Boggs Bridge in Luling is expected to bring with it more commercial opportunities and construction jobs.

St. John the Baptist Parish has noted a recent boom in residential and commercial growth with release of Landmark Land Property.

Another growth sector of the economy is the ship building and repair industry. Shipbuilding interests have diversified their clientele and thus are picking up many of the skilled workers laid off by more petroleum dependent concerns.

### *Evaluation of Effectiveness in Meeting Goals*

In determining the effectiveness of meeting goals, a brief analysis of projects as related to the 1997 OEDP and the Reform Act goals will be performed annually. The review will be done in partnership with the local economic development committees and regional CEDS task force. Comments and direction for improvements will be included in the annual report to the Regional CEDS Committee.

The goals and objectives met are organized herein in order to demonstrate their relationship to the goals of the 1998 Reform Act. A review of the goals and objectives met thus far, it was seen that a few are duplicative. Improved living conditions and job training might better be addressed in years to come. Much of the emphasis in the past years has been directed toward the diversification and stabilization of the economy. This emphasis is justified given the hard times experienced in the mid-1980s when the primary industry within the region drastically declined. The fruits of this labor are being felt now as the petroleum industry is once again on a down cycle yet growth in the region continues. In order to avoid such collapse in the future, emphasis on strengthening the Region's growth industries must be maintained. SCPDC is looking forward to the completion of the EDA's Economic Base Analysis which will help guide local economic practitioners in improving their diversification efforts.

## ***Goals for the Coming Year***

After review of the 1997 OEDP with the various local committees, task force and OEDP Committee, the following goals were determined to be priorities for 1999. 

***Resolution of Appreciation to Mr. Todd Pellegrin***

A motion was made by Mr. Bailey, seconded by Mayor Townsend to adopt a resolution in dedication to Mr. Todd Pellegrin for his time served as Chief Executive Officer of South Central Planning. There being no opposition, the motion passed unanimously.

***Acceptance of Minutes of June 30, 1998 Regular Meeting***

A motion was made by Mayor Townsend, seconded by Mr. Hymel to accept the minutes of June 30, 1998. There being no opposition, the motion passed unanimously.

***Acceptance of Minutes of August 12, 1998 Special Meeting***

A motion was made by Mr. Bailey, seconded by Mayor Townsend to accept the minutes of August 12, 1998. There being no opposition, the motion passed unanimously.

***Presentation of 1997-98 Annual Audit by Bourgeois Bennett, LLC.***

Ms. Deanna Zeringue of Bourgeois Bennett, L.L.C. presented the 1997-98 Annual Audit to the Board of Commissioners. Ms. Zeringue explained the audit report to the members of the Board and stated that South Central Planning did not have any findings and that this year's audit was very good.

Mayor Townsend asked Mr. Poché if the agency's computers were Year 2000 compliant. Mr. Poché replied that the agency's computers are 2000 compliant.

A motion was made by Mr. Kraemer, seconded by Mayor Townsend to accept the 1997-98 Annual Audit. There being no opposition, the motion passed unanimously.

***Discussion of SCPDC Employee Retirement Plan.***

Mr. Belanger introduced Mr. Jim Ray of PebSCO. Mr. Ray presented and discussed different scenarios. He compared South Central Planning's retirement with some of the other planning districts in the state and also the differences in the rate of turnover of employees. He stated that the 457 plan is voluntary, whereas the parochial plan is mandatory. Mr. Jim Ray recommended bringing the plan back to what it once was.

Mr. Kraemer asked how South Central Planning stood budget wise. Mr. Belanger stated that 6% has already been budgeted this year beginning in January. Mayor Townsend said that the agency's contribution could go up or down depending on its financial status. Mr. Belanger stated that the retirement would be one of the first areas the agency would look to cut back if we run into bad times.

Mr. Belanger explained that the cost to the district to match at 6% would be around \$13,000 assuming that everyone takes advantage of the 6% maximum.

A motion was made by Mr. Kraemer, seconded by Mr. Bailey to accept the 6% dollar for dollar match plan. There being no opposition, the motion passed unanimously.

***Discussion of Vehicle Lease***

Mr. Belanger explained that when he was hired, he and Ms. Elizabeth Breaux looked at the mileage that was going to be put on the agency vehicle. He stated that it is estimated that the agency will spend about \$19,000 in the three (3) year period and have no collateral in the end. He said that he feels that the agency could sell the vehicle for what it is worth which is \$22,500. He explained that he had received the permission of the Management Committee to bring the vehicle to Terrebonne Ford to try to sell. He said that the management of Terrebonne Ford felt that we could probably get some offers within two weeks. He stated that the agency will not accept anything less than \$22,500. He said that if the agency is able to get \$22,500 we will sell the vehicle and go out on state contract to purchase a new vehicle.

A motion was made by Mr. Bailey, seconded by Mr. Sylvester to sell the agency vehicle with the exception that we get an offer of \$22,500. There being no opposition, the motion passed unanimously.

### ***Discussion of Regional Landfill***

Mr. Bonvillain stated that Terrebonne Parish is interested in trying to create a regional landfill or Solid Waste Management Authority and to possibly begin having meetings on a regular basis.

Mr. Belanger stated that South Central Planning held a meeting on October 20<sup>th</sup> at Nicholls and had representation from Terrebonne, Lafourche, St. Charles, St. James and St. Mary Parishes. Mr. Belanger stated that the report that was generated by the University of New Orleans in 1994 was reviewed. He said that it was discussed as to what could be done to gain the interest of the political leaders. He said that the people who were at the meeting are the people who are actually involved with the solid waste problems. He said that it was concluded at the meeting that the best route would be to show the amount of savings or to try to extrapolate what was done in 1994 and to be able to show the parishes what potentially could be the savings to all of the parishes. He said that the Corp of Engineers eluded to a program that would pay 50% of any study that is done in light of looking at the cost/benefit ratios. Mr. Belanger stated that he met with the gentleman from the Corp of Engineers after the meeting and that they began to put together a scope of services. He said that an approximation of the cost of the study could possibly be in the range of \$50,000.00 which would be conjointly undertaken by South Central Planning, the Corp of Engineers, and the Department of Environmental Quality. He said that DEQ had initially funded the 1994 study through the University of New Orleans through a grant that was received by the Department of Natural Resources, and DEQ will look to see if SCPDC could get the money for the study. He said that if there are seven parishes involved, we would look at about \$3,000.00 per parish to perform such a study. He said that there will be a meeting in mid November to issue the scope of work and hopefully to have an amount so that we can ask the parishes for contributions to the study.

### ***RESOLUTION: Certification for Capital Outlay.***

A motion was made by Mr. Hymel, seconded by Mr. Bailey that the Board adopt the resolution regarding certification for Capital Outlay. There being no opposition, the motion passed unanimously.

### ***Building Project Status Report***

Mr. Belanger stated that US Hwy. 90 has be designated for I-49 in years to come. He said that this has negated the possibility of the agency being able to use the right-of-way along LA Hwy. 311 and U.S. Hwy. 90.

Mr. Belanger stated that the State is going to close on the purchase of the Delta College site, but will not purchase the remaining 2½ acres located in front of the building. He said that Speaker Downer is trying to negotiate a trade with Donald Rouse of the state owned property on the corner of Coteau Road and Hwy. 24 for the property in front of Delta College. He said that

Speaker Downer stated that if he can get the site successfully through the Highway Department that he will get us 2 acres at a minimum.

Mr. Belanger stated that he has been in other negotiations with private land owners in the vicinity of Hwy. 90 and Hwy. 24 which in his opinion is the area where the facility should accessibly be located. Mr. Belanger recommended that SCPDC be allowed to make a Capital Outlay Request to the legislature in the approximations of about \$100,000 to \$150,000 to be able to purchase property.

Mr. Bailey reminded the Board again of the offer of land in St. John the Baptist Parish. Mr. Kraemer stated that there are numerous private land owners in Lafourche Parish that SCPDC could possibly look at.

Mr. Bonvillain asked Kevin where the agency stood with the architect of the project. He said that we need to hold him back until we are sure where the building will be located so that it can be designed for the land. Mr. Belanger stated that the architect is about 85% complete on the plans and that the footprint of the building can be placed anywhere as long as you have a width greater than 150'.

#### ***Discussion of SCPDC's Lease with Carl Heck.***

Mr. Barry Bonvillain stated that the agency could possibly negotiate with Mr. Carl Heck about the possibility of purchasing the building where SCPDC is presently located. Mr. Belanger stated that Mr. Heck is very interested in selling the building. He said that Mr. Heck would like to see the agency remain in the building indefinitely. Mr. Belanger stated that Mr. Heck has brought to him on two occasions electric bills in excess of \$600.00 and asked that in the future lease the Board would give consideration to increasing the amount by about \$300.00.

#### ***RESOLUTION: Electric Industry Competition in Louisiana Support for Entergy Louisiana.***

Mr. Harry Shields of Entergy explained Electric Utility Deregulation with the Board. A motion was made by Mayor Townsend, seconded by Mr. Bailey to accept the Resolution supporting Entergy Louisiana. Mr. Barry Bonvillain abstained from voting on this matter. The motion carried.

#### ***Agency Activity Report***

Mr. Bonvillain briefly discussed the Agency Activity Report.

A motion was made by Mayor Townsend, seconded by Mr. Hymel to accept the Agency Activity Report.

### ***Other Business***

Ms. Pamela Ehlers asked Mr. Belanger for an update on how the agency was distributing the RLF money. He said that the agency has received two requests from St. Charles Parish and that these are the only two received in the last month.

#### ***Acceptance of Minutes of October 22, 1998 Regular Meeting***

A motion was made by Mr. Bailey, seconded by Mr. Aubert to accept the minutes of October 22, 1998. There being no opposition, the motion passed unanimously.

#### ***Review Financial Statement ending December 31, 1998***

Mr. Belanger stated that as of December 31, 1998, SCPDC had total assets of \$364,612.11, total liabilities of \$10,542.35, and a total fund equity of \$354,069.76. He stated that on the Statement of Revenues and Expenditures the agency has total revenues of \$287,661.10, total expenditures of \$244,666.81 and an excess balance of \$42,994.29. He stated that the ending fund balance as of December 31, 1998 was \$275,537.31

A motion was made by Mr. Fanguy, seconded by Mayor Townsend to accept the Financial Statement ending December 31, 1998. There being no opposition, the motion passed unanimously.

#### ***Election of 1999 Officers***

Mr. Bailey made a motion, seconded by Mr. Aubert to open nominations. There being no opposition, the motion passed unanimously.

A motion was made by Mr. Fanguy to nominate Mr. Dale Hymel as Chairman of SCPDC. Mr. Aubert seconded the motion and the Board voted unanimously to accept Mr. Hymel as Chairman.

#### ***Building Project Status Report***

Mr. Belanger explained that he has a meeting set for March 11, 1999 to discuss the possibility of the highway department acquiring the property in front of the Delta College building. He stated that he has been working on setting up a meeting with the Secretary of the Highway Department regarding the property for the past 3 to 4 months. He said that the Secretary is receptive to the idea but would like to see what SCPDC plans on building.

Mr. Belanger stated that he has spoken to Mr. Carl Heck, Sr. regarding the building we are now located in. He explained that Mr. Heck was having health problems at the time and was unable to attend to the matter. Mr. Belanger said that Mr. Heck came by this morning regarding a proposal that would give the agency an idea of what he would be asking for the building.

Mr. Belanger also stated that the agency has submitted a Capital Outlay Request for the remainder of the money for the building.

#### ***Acceptance of Minutes of January 28, 1999 Regular Meeting***

A motion was made by Mayor Townsend, seconded by Mr. Bailey to accept the minutes of January 28, 1999. There being no opposition, the motion passed unanimously.

#### ***Review Financial Statement ending May 31, 1999***

Mr. Belanger stated that as of May 31, 1999, the agency had total assets of \$526,793.28. He said that the agency had total liabilities of \$158,559.53 and a total fund equity of \$368,233.75 for a total liabilities and fund equity of \$526,793.28.

A motion was made by Mayor Townsend, seconded by Mr. Bailey to accept the Financial Statement ending May 31, 1999. There being no opposition, the motion passed unanimously.

#### ***Review and Approve FY 1998-99 Budget Adjustments.***

Mr. Belanger asked Ms. Elizabeth Breaux to go over the budget amendments. Ms. Breaux stated that adjustments were made to make the budget more in line with the ending year numbers rather than what was proposed at the beginning of the year. She stated that there were only slight adjustments. She said that the agency purchased less supplies than budgeted, salaries

were decreased to reflect that there was no CEO for some of the year, and some of the salary money was moved into fringe benefits for vacation time and leave time. Ms. Breaux stated that on the last page there is a budget comparison which shows the difference between the adopted budget and the amended budget.

Mr. Hymel pointed out that under the general fund for the 98-99 budget amendment the agency is \$63,699.00 to the good and under the special revenue fund the agency is in the good by \$304,533.00. He stated that when the proposed budget for 1999-2000 year is presented you will see a deficit of \$252,455.00 under the special revenue fund. He stated that basically this is just a timing difference where the revenue is recorded in one year and the expenditures comes out in the following year.

Ms. Breaux stated that the special revenue is due to America's Cajun Restaurant paying back their RLF loan. She stated that the special revenue is totally the RLF money and that the money will be loaned out next year.

A motion was made by Mr. Bailey, seconded by Mayor St. Pierre to approve the FY98-99 budget adjustments. There being no opposition, the motion passed unanimously.

#### ***Review and Approve FY 1999-2000 Proposed Budget.***

Mr. Belanger stated that the agency's projected deficit for the 1999-2000 budget is \$76,317.00. Mr. Belanger pointed out the attachment that outlines contracts that the agency is currently pursuing. Mr. Belanger stated that highlighted items are the contracts the agency expects to have within the next three months. He stated that the agency has been notified by the Department of Labor that the Susan Harwood Grant has been awarded to our agency. SCPDC was also chosen by the Lafourche Parish Library to do marketing and public outreach for \$18,000.00. He said that the other contracts that he feels certain the agency may receive within the next three months are the Town of Litcher Comprehensive Plan Update for \$8,000.00, St. Charles Community Boundaries for \$12,000.00, and the Bayou Lafourche Fresh Water District educational awareness effort for \$20,000.00.

Kevin stated that the agency is currently pursuing the Metropolitan Planning Organization (MPO). He stated that he has done some comparison of our district throughout the state. He said that SCPDC has been in operation since 1972, and has operated roughly on 33% reoccurring sources of revenue. He stated that the other 67% is contract work that the agency has to pursue. In comparison to the other districts within the State of Louisiana, all except for one are basically what we term the MPO and have a source of reoccurring revenue each year through the Louisiana Department of Transportation. He stated that South Central Planning becoming the MPO would not only benefit Terrebonne, Lafourche, and the City of Thibodaux, but also would have some benefits to the other areas of the region.

Mr. Hymel stated that if SCPDC were to become the MPO he would like to make sure that it would benefit Terrebonne Parish as well as Lafourche Parish and the City of Thibodaux. He said he would like this to be a win-win situation for all involved.

Mr. Hymel asked what would have to be done for the MPO to be transferred to SCPDC. Mr. Belanger stated that all three entities would have to pass ratifying resolutions to form the MPO at South Central Planning. Mr. Belanger also stated that the key to making this work is that Terrebonne shall not feel threatened of losing anything. He said that the way to make this happen is to let Terrebonne have control even after the MPO is transferred to South Central Planning.

A motion was made by Mr. Bailey, seconded by Mr. Sylvester to accept the proposed 1999-2000 budget. There being no opposition, the motion passed unanimously.

***Resolution: Adopting Systems Survey and Compliance Questionnaire.***

Mr. Belanger stated that this is done annually to assure that the audit is being done properly and efficiently.

A motion was made by Mr. Tregre, seconded by Mr. Bailey to accept the resolution adopting the systems survey and compliance questionnaire. There being no opposition, the motion passed unanimously.

***Resolution: Certifying the RLF Program is consistent with the current regional economic adjustment strategy; is being operated in accordance with the policies and procedures contained in the plan; and, that all loan portfolios meet plan standards.***

Mr. Belanger stated that every year we have to pass a resolution giving certification that our revolving loan fund is being administered in the proper fashion and is consistent with our Comprehensive Economic Development Strategy.

A motion was made by Mr. Bonvillain, seconded by Mr. Bailey to adopt the resolution certifying the RLF Program. There being no opposition, the motion passed unanimously.

***Approval of 1999 Comprehensive Economic Development Strategy (CEDS).***

Mr. Belanger stated that representatives from the agency went to all Parish economic development departments and committees to receive updates for the CEDS. He said that the agency also held a Regional Economic Development Strategy meeting about two weeks ago to discuss and receive comments on the Plan. He said that this report was compiled as an update the CEDS program.

A motion was made by Mr. Sylvester, seconded by Mr. Tregre to accept the CEDS report for 1999. There being no opposition, the motion passed unanimously.

***Discussion of Lease for Carl Heck Engineers Building.***

Mr. Belanger stated that a Management Committee Meeting was held last week and that he had asked for approval to enter into a lease with Mr. Heck. Mr. Belanger explained that the agency had problems with the A/C unit about two months ago. A lot of work was done to repair the problem that Mr. Heck wanted the agency to pay for. Mr. Belanger stated that the lease was

never signed by Mr. Heck last year. He said that after reviewing the lease from the previous year, we were not responsible for any charge exceeding \$200.00. He said that Mr. Heck agreed to pay the A/C bill, but asked that the agency increase our rent to take into consideration some of the repairs that he has been taking care of as well as the electricity bills that he receives. Mr. Belanger stated that he told Mr. Heck that if he would like the agency to increase the rent, SCPDC would have to seek other comparable sites. He said that Mr. Heck then agreed to leave the lease as it is now.

### ***Status Report of SCPDC Building Project.***

Mr. Belanger stated that Speaker Hunt Downer called this past Monday to say that our Capital Outlay Request for this year has been approved. He said the money will be available by October to build the building. He said that the Division of Administration did give approval to the Highway Department to acquire the land in front of Delta College. He said that the Highway Department received appraisals on the land, and are currently negotiating with Donald Rouse. The Highway Department expects to have this concluded by the end of July.

### ***Agency Activity Report***

Mr. Belanger briefly discussed the Agency Activity Report which includes all activity by the agency since the January 28, 1999 meeting. Mr. Hymel asked the Board to take a look at what is being done in other parishes and municipalities to see if there is a need in their Parish or Town for SCPDC to contract out work.

### ***Other Business.***

Mr. Hymel deviated from the agenda to present a condolence resolution in memory of Jervis Autin. All present stood in a moment of silence in his honor.

A motion was made by Mayor Townsend, seconded by Mr. Bailey to adopt the resolution for Mayor Autin. There being no opposition, the motion passed unanimously.

### ***Corporate Sponsor Presentation***

Mr. Dale Hymel introduced the Corporate Sponsor Mr. John DeFraites of GSE Associates and allowed him to make a presentation. Mr. John DeFraites spoke briefly about the organization and showed a video on storm water management.

There being no further business to discuss, a motion was made by Mr. Labat, seconded by Mr. Bailey to Adjourn. There being no opposition, the motion passed unanimously .
