
# Louisiana Community Development Block Grant 2022


Environmental Record Review Training Session Baton Rouge, Louisiana

The training was a success and all participants benefitted from the instructors of Denease McGee and Fenishia Favorite.


# **Louisiana Community Development Block Grant 2023**


#### Baton Rouge, Louisiana

Shannon Edgerson, Lea Ann Rucker, and Thomas Rhodes of South Central Planning and Development Commission attended the Louisiana Community Development Block Grant Civil Rights and Labor Compliance Training hosted by the Louisiana Office of Community Development on January 10 and January 11, 2022 at the Claiborne Building in Baton Rouge, Louisiana. Mr. Edgerson, Ms. Rucker, and Mr. Rhodes along with others from all over the State of Louisiana were involved in learning about the Equal Employment Opportunities, Fair Housing, Section 504, and Section 3 for the Civil Rights Training and for the Labor Compliance Training, we all learned the regulations and requirements of the Davis-Bacon Related Acts, Copeland "Anti-Kickback" Act, Contract Work Hours and Safety Standards Act (CWHSSA), Louisiana Law, and the LCDBG requirements for labor compliance in addition to Wage Decision, Fringe Benefits, Force Account Labor Employee Interviews, Labor Standards, the classification of Unfound Workers and Falsification, Payroll Retention and Payroll Review. The training was a success and all participants benefitted from the instructors of Denease McGee who directed the Civil Rights Training and Fenishia Favorite who directed the Labor Compliance Training.

# Updated Codes Effective January 1, 2023

The Louisiana State Uniform Construction Code Council have adopted updated codes that are effective for all permits that are applied for on or after January 1, 2023. The updated codes are the 2021 version of the International Codes with Louisiana amendments and the 2020 version of the National Electrical Code with Louisiana amendments. Several classes were given by the SCPDC team at multiple HBA meetings over the last few months. For those permit applicants that were unable to attend these classes, handouts highlighting the significant code changes they should be aware of have been provided to all the permit offices to hand out.

There will be more changes to come later in the year with the adoption of the 2021 International Energy Conservation Code and the 2021 Energy Chapter of the International Residential Code both with Louisiana amendments. These changes will become effective for all permits applied for on or after July 1, 2023. Prior to that date, we will, once again, hold educational sessions to make sure our building community is informed and prepared to adapt to the new regulations.
