SOUTH CENTRAL SAFE COMMUNITY TASK FORCE

ARTICLE I NAME

The name of the organization shall be the South Central Safe Community Task Force. Or is it South Central Safe Community Partnership?

ARTICLE II AUTHORIZATION

The South Central Safe Community Task Force was created in November 1999 under provisions of a grant awarded to the South Central Planning and Development Commission by the Louisiana Highway Safety Commission for the specific purpose of creating a ~~regional~~-Safe Community Program for South Central Region-

ARTICLE III PURPOSE

The South Central Safe Community Task Force ~~is~~ was organized for the purpose of ~~creating~~developing and implementing an Action Plan ~~to that~~ reduces the incidence of traffic crashes in the six-parish region of Assumption, Lafourche, St. Charles, St. James, St. John the Baptist and Terrebonne and to implement the Action Plan through the creation of a Safe Community Fund and a Media Campaign.

ARTICLE IV MEMBERSHIP OF THE TASK FORCE

Membership ~~on~~in the Task Force shall include any citizen or agency representing any of the aforementioned parishes of the six parish area interested in supporting efforts and executing projects that are designed to -reduce the incidence ~~-number~~ of traffic crashes in the region by focusing on the causes thereof.

ARTICLE V MEETINGS

The Task Force shall meet at least once a month during its initial year of planning. Thereafter, the frequency of meetings may be decreased to quarterly if the membership determines its suitability. ~~that is more suitable.~~

ARTICLE VI POLICIES AND PROCEDURES

The Task Force shall elect officers annually by vote of a majority of members present. Elections shall occur in December of each year. Special elections may be held as needed in order to fill vacancies on the Board. A simple majority vote (including those by proxy) of those members present shall be necessary to carry any motion.

Any member of the Task Force or Executive Board may vote at any meeting of the membership by proxy. All proxies must present a written letter of authorization in order to vote on behalf of the absentee member and a record must be kept in the minutes of the meeting of all proxies voted in the meeting. Proxy representatives cannot grant proxies to representatives or alternative representatives of another member.

ARTICLE VII COMMITTEES

Standing Committees:

1. ~~1.~~ **The Executive Board**

1.1 **The Executive Board** shall be composed of not more than 21 members of the Task Force including the officers. It shall have at least one (1) and not more than three (3) representatives from each of the six parishes in the South Central Region. Each representative shall reside within or work for an agency serving the parish to be represented. The three representatives from each parish shall not all be from the same agency. In addition there shall be three (3) at-large members who represent more than one parish as a result of the agency at which they are employed.

1.2 The Executive Board shall develop policies and procedures, review and approve applications for funding under the Safe Community Fund, and report awards to the Task Force, Louisiana Highway Safety Commission and the South Central Board of Directors.

1.3 The Executive Board shall meet monthly during the initial planning year of the program and may amend its meeting schedule thereafter by majority vote. The Chair and Vice Chair of the Task Force shall serve as Chair and Vice Chair of the **Executive Board**. In order for motions to be made, a majority of the Board must be present. A quorum shall consist of five (5) members and one (1) officer, which is a total of six (6) members.

2. The **Executive Committee** shall be comprised of the officers of the Task Force/Executive Board.

Special Committees:

The Task Force may create special committees as needed. The Chair shall appoint committee chairs.

ARTICLE VIII OFFICERS OF THE TASK FORCE AND EXECUTIVE BOARD

The officers of the Task Force and Executive Board shall be the same and shall include the Chair, Vice Chair, Secretary and Treasurer. The Secretary/Treasurer may be combined. The same persons shall serve as the officers of the full Task Force.

The Chair shall convene regularly scheduled meetings and shall preside or arrange for other members of the executive committee to preside at each meeting.

The Vice-chair will chair committees on special subjects as designated by the board and serve in the absence of the Chair.

The Secretary shall be responsible for keeping records of meetings, including minutes of all meetings, sending out meeting announcements, distributing copies of minutes and the agenda to each member and assuring that records are maintained.

The Treasurer shall make a report at each meeting. The Treasurer shall assist in the preparation of the budget, help develop fundraising plans, and make financial information available to the members.

Ms. Cazaubon spoke about the Safety Management Meeting that was conducted by the Highway Safety Commission. She said that she has prepared a letter to the Lafourche Parish President about possibly installing a street light at the intersection, and asked that everyone take a look at the letter and sign before leaving.

Discussion ensued regarding the Applications for Subgrants. Capt Diaz stated that South Central Planning received seven applications totaling \$54,417.98. The Safe Community program has \$46,000.00 to award for grant funding. Capt Diaz informed the Board that Ms. Cazaubon called the applicants to see if the applications could be re-evaluated to possibly cut a few dollars off of each grant. There was also discussion about the possibility of moving some money from the media campaign and salary portion of the grant where these areas may run under budget.

The Chairman allowed each of the applicants the opportunity to give a brief presentation on their project.

Capt Diaz asked for approval on each of the applications.

Ms. Cazaubon updated the Board on some other sources of funding she checked into. She said that the Lorio Foundation only funds within the City Limits of Thibodaux for Capital Improvements. Ms. Cazaubon said that the Gheens Foundation, out of Louisville, KY, is very vague about what and where they will fund. The Gheens Foundation has a large land holding in Lafourche Parish, and will fund some projects in the Lafourche/Terrebonne area. Ms. Cazaubon said that she asked about the possibility of acquiring funding for a regional project and was told to send it in, and they would look at it. She felt this might be a good place to go for funding for ATV activities and possibly for funding Ralph Mitchells request for funding for radar equipment to be used throughout the Troop C area. Ms. Cazaubon also mentioned that she spoke with Lt. Colonel Santos and the kinds of projects his program usually fund is something that results in training for the National Guard. He said that some community projects are considered, but he likes the projects to involve hands on training for their people.

T. Diaz informed the Board about a bike safety program that will be held at Thibodaux Hospital's outpatient building on March 14th at 12:00 p.m.

T Diaz stated that Bob Canfield would like the Safe Communities Task Force to identify traffic safety problems that can be corrected by infrastructure changes, construction changes, etc. M. Cazaubon said that she thinks that Mr. Canfield would like the Safe Communities program to identify three (3) problem sites in each community and then try to get some information on the cause of the problem. Ms. Cazaubon stated that Richard Poché of SCPDC is working with Sgt. Darren Naquin of the LA State Police to map some of the traffic data. She said that the SCSC would be able to use this information to identify the numbers of crashes and the causes to document if there really is a safety problem. T. Diaz suggested that at the next meeting information be turned in, outlined in a short paragraph, along with any statistics to back up the information so that it can be incorporated into a presentation to Mr. Canfield.

T. Diaz introduced the guest speaker Ms. Bridget Schumert, R.N of Charity Hospital. Ms. Schumert spoke to the group about many of the hospital's new programs such as School-Based Trauma Prevention Outreach Program, Mock Trauma Tours, Alcohol Awareness – Making the Right Choice, KICS – Kids in Car Seats, the Louisiana Passenger Safety Task Force, and the Louisiana State Police's involvement in the Alcohol Awareness Program. Ms. Schumert informed the Task Force about an upcoming conference called Lifesavers to be held in March 2001. She said that she attended last year and will be attending again this year. She said that the amount of information the conference has is incredible. Ms. Schumert also informed the Task Force of another conference called the Safety Technical Conference. She said that this conference is specific to child passenger safety and will be held in June 2001.

There was further discussion on child safety seats.

Mr. Dan Magri of the Louisiana DOTD updated the Task Force on Highway issues that have been discussed in the past.

T. Diaz stated that Darrin Naquin of the Louisiana State Police Troop C would like to incorporate the Incident Management meetings with the Safe Communities meetings. He said that the SCSC would work with the State Police to try to incorporate the two meetings into one day per month.

T. Diaz said that Bob Canfield, a Traffic Engineer for the State has asked the SCSC to put together a list of three different traffic issues in each community that could be brought to his attention. He asked that this information be presented at the next meeting.

T. Diaz introduced the guest speaker Capt. Ralph Mitchell. Capt. Mitchell gave an update on Traffic Stats. He stated that Troop C would like to partner up with some of the educational aspects of the Safe Communities Program. He felt that the program could help with pedestrian issues by letting people know that the highway is not a place to walk or play.

Capt. Mitchell discussed the driving habits of NSU Students. He said that the students leave and drive at excessive speeds, cut through private property and go the wrong way on the couplet in order to miss red lights. He said he spoke to Representative Warren Triche about possibly having a Public Information Officer speak to the students in the Student Development course at NSU about the problem.

Capt. Mitchell stated that if there is any program that the State Police could assist with to give them a call.

Capt. Mitchell said that the State Police would begin to issue citations to tailgaters. He explained that an educational program was created to target tailgaters and passed out a sample brochure that will be used.

He also added that the Assumption Pioneer had a story on the funding that the Assumption Parish Sheriff's Office received from the Safe Community Program.

M. Cazaubon stated that Pam Roussel would check into the cost of pencils and book covers for the start of the next school year.

M. Cazaubon stated that it sounds like a light and possibly a turning lane will be placed at Elm Street in LaPlace.

An update was given on the status of the intersection of LA 3235 and LA 3161 in Lafourche Parish. Rumble strips and signage have been installed at the location.

M. Cazaubon stated that she has not heard from Bob Canfield about the two (2) problems in Assumption Parish and the problem with River Road in St. Charles Parish.

Discussion developed on the Incident Management Program.

Mr. Duane Schexnayder of the Louisiana State Police gave an update on the Traffic Stats Program. He responded by saying that the program is wonderful. He said that he does not recall the statistics but said that they are down anywhere from 7 to 12 percent. There was discussion on the active enforcement of the area between LA Hwy. 20 and the U.S. 90 overpass.

Discussion developed on the new legislation before the house and senate regarding DWI, seat belts and child safety seats. Mr. Thompson said that a bill that would stop people under 21 from entering bars was defeated at committee level.

M. Cazaubon stated that there have been a lot of news articles over the last month regarding traffic safety. She said that included in the packets are two articles that pertain to the South Central Safe Community projects in Assumption and Terrebonne Parishes.

M. Cazaubon stated that everything is pretty much complete with the subgrants, but is unsure if Assumption's project is complete. She said that SCPDC has not been invoiced from Lafourche or Terrebonne yet, but understand that the invoices are in the works.

The bike helmet bill will be discussed in the Senate Transportation Committee today. The penalties the Committee is looking at right now are: 1st offense equals a warning, 2nd offense would be a \$25.00 fine and the 3rd offense and over would be a \$50.00 fine. Also, under this legislation the Highway Safety Commission must provide money to Safe Kids Incorporated to purchase bike helmets for indigent kids. A question was asked as to whether this bill includes adults too. Ms. Cazaubon stated that she would check with Mr. Thompson to find out if the bill does include adults.

The legislation requiring seat belts to be worn by back seat adult passengers will be voted on today on the House floor. If it passes the bill will go before the Senate. She said that there have been a lot of revisions and changes to the legislation.

M. Cazaubon said that there was a procedural move to reintroduce the 0.8 blood alcohol level legislation on the House Floor, which passed two days ago. The House Floor voted the 0.8 bill down by almost a two to one margin on May 23rd.

M. Cazaubon stated that Capt. Mitchell of the Louisiana State Police Troop C is interested in holding a bicycle rodeo and asked if the Task Force could help them organize the rodeo by pulling together resources.

Discussion ensued regarding work zone safety and the possibilities of an OSHA grant to do training safety programs. M. Cazaubon stated that next year's grants include highway construction safety. She said that SCPDC has done an OSHA grant before for shipyard safety.

M. Cazaubon updated the Task Force on the Subgrants. She said that everyone is pretty much done with the projects. Mr. Authement introduced Duane Schexnayder of the Louisiana State Police. Mr. Schexnayder discussed Incident Management. He said that Capt. Mitchell asked that Incident Management be placed on the Safe Community meeting agenda in order to try to reduce the amount of meetings since the two pretty much encompass the same people. Mr. Schexnayder discussed a basic outline of a Highway Incident Management Course.

Cazaubon said that she checked with the DOTD District Office, which covers St. John, and they are still waiting to hear on the Elm Street light and turning lane.

M. Cazaubon introduced Kevin Ghirardi who is the MPO Administrator for South Central Planning. Mr. Ghirardi gave an update on what is going on with the Metropolitan Planning Organization.

M. Cazaubon introduced Leslie McVeigh who also works with South Central Planning. M. Cazaubon said that South Central Planning is looking at the possibility of receiving some OSHA funds to set up a safety training program in the Region for the highway construction industry. It was moved by D. Matherne, seconded by L. Landry to approve the minutes of June 21, 2001. There being no opposition, the motion passed unanimously.

Chairman Diaz stated that there is no real change on the status of the subgrants that are in progress.

There was discussion on the quotes that were received for bookcovers, etc. for the media campaign. T. Diaz suggested that M. Cazaubon put together a list that would maximize the dollar to get about ½ bookcovers and a mixture of the other items. T. Diaz suggested that the bookcovers include the names of all participating agencies of the Safe Community Program. M. Cazaubon stated that she would find out how much more the addition to the bookcovers would cost.

M. Cazaubon discussed the Walk Your Child to School Day Program. She said that she spoke to the State Coordinator, who could not attend today's meeting but agreed to meet with the Committee at a later date. A meeting date is tentatively set for August 3, 2001.

L. Robinet spoke about the need for a traffic light on LA 44 and Elm Street in LaPlace. He said that there have been conversations with Mr. Dan Magri and Mr. Kitchen of DOTD. He said that a survey was performed and there is definitely a need for a traffic light and a turning lane at the intersection it could take a year or two before it happens. He said that the project would cost close to \$900,000.00. L. Robinet asked if the Executive Board would express its concerns to the legislative committee to expedite the project.

G. Falgoust stated that DOTD Representative Mr. Roy Schmidt informed him that the widening of LA 20 should start in about one month. He added that Mr. Schmidt also said that the area from the Bayou Chevreuil Bridge to the Lafourche Parish line bridge would be recommended to be elevated twenty inches.

There was discussion regarding possible grant applications. M. Cazaubon stated that SCPDC has submitted an application for a grant that targets teen safety which was discussed at the last meeting. M. Cazaubon said that she has contacted the State S.A.D.D. Executive Director and their organization is interested in partnering with the Safe Communities program for the grant. She said that the maximum amount that could be applied for was \$250,000.00. Seventy-five percent (75%) would go toward enforcement. Money was also included for intoxilizers, hand held radars, a speed trailer, education and outreach, travel and support staff.

M. Cazaubon stated that she is currently working on an application for the rational speed limit. She said that the average funding range is from \$175,000.00 to \$300,000.00. M. Cazaubon said that everyone she has talked to is interested, but not necessarily committed yet. She said that the City of Thibodaux does not want to participate at this time. M. Cazaubon explained how this project would work if funded.

M. Cazaubon discussed another possible grant to reduce alcohol impaired driving by individuals age 21 through 24. She said that this program would have the help of the ADAC's. This application is due on August 3, 2001.

M. Cazaubon also informed the Board of another application due on August 1, which is regarding seat belt and child restraint education and use among SUV occupants. She said that only two projects would be funded nationwide in the amount of \$350,000.

G. Falgoust discussed a demonstration of how long it takes an auto to stop at different speeds. He asked about a simulator machine that he saw years ago that accomplished this task.

M. Trahan said that there is a demo ride that shows how an SUV would roll over.

A. Knobloch stated that she could probably do an outreach presentation regarding alcohol and safety belt use for two days in the fall and two days in the spring with student nurses.

M. Cazaubon stated that Bob Thompson cautioned her about booking people too much on overtime for the grants. She asked what would be a reasonable amount of overtime to expect from a law enforcement agency for one month. She said that Mr. Thompson said that 20 hours might be a reasonable amount. There was further discussion on this matter.

T. Diaz said that Lafourche Parish Sheriff's office has a consultant who works under contract to write grants for their office. He said that the Sheriff's office plans to have their consultant help Ms. Cazaubon to write some of the grants for the Safe Community group.

There was discussion about an upcoming grant-writing program.

Dr. Viator commented that he thought the demonstration of how long it takes a vehicle to stop is a good idea that G. Falgoust referred to. He added that the Safe Community program could partner with the schools to use this as a physics project. He asked if there is any grant money available to design a simulator. T. Diaz stated that through discussions with Jim Hogue, he was told that NHTSA would sometimes fund experimental projects. There was discussion as to who would have the capabilities to design such a project.

He said that in a nutshell, LHSC cannot fund other bicycle helmet programs because of the Legislative deal and it is not in a problem I.D.

M. Cazaubon stated that the other items that Assumption Sheriff's Office is asking for is the fatal vision goggles, golf cart, cones, and three videos to use for educational programs which comes to a total of \$2,100.00. Also requested were three radars for a total of \$6,975.00

M. Cazaubon said that the other items for Lady of the Sea are all eligible as long as it relates to traffic safety issues.

M. Cazaubon said that everything that the Thibodaux Police Department, St. James Sheriff's Office, and the Houma Police Department requested are eligible.

M. Cazaubon said that Lafourche Parish Sheriff's Office was asking for funds to send two officers for training at the Lifesavers National Conference. She explained that B. Thompson has explained that there is another fund this year which can be used to send people to this program. Other items requested by Lafourche Sheriff's Office are eligible.

It was moved by L. Landry, seconded by C. Authement to accept the minutes of the meeting held on January 24, 2002. Motion carried.

T.Diaz gave a report on NHTSA presentation. M. Cazaubon gave an update on the NHTSA grant. M. Cazaubon has received information from some of the law enforcement agencies in the six parish area. Cazaubon had heard from four of the six parishes.

Discussion ensued regarding the upcoming Traffic Summit. The committee wants to develop an aggressive driver campaign as part of the Traffic Summit. It was suggested that the Task Force get in touch with other groups such as New Orleans and Baton Rouge traffic committees. The committee wants to mail letters to other organizations to encourage support and similar initiatives.

M. Cazaubon discussed media campaign for 21-34 Drinking and Driving prevention sponsored by the State. There is a meeting next week with Bob Thompson and Lyrica Johnson. Baton Rouge Metropolitan Safety Council is also doing a similar project. We would like to see how their project is structured.

The Media Campaign was discussed. Some banners were made for Operation Buckle Up. Banners say congratulations to Houma/Thibodaux area for the most compliance of the law. Banners are available without Houma/Thibodaux. Banners can be made for each parish. Media campaigns must recognize LA Highway Safety Commission.

Capt. Diaz said items can be ordered for free off the NHTSA website in a limited quantity, but if you call and order from NHTSA's D.C. office directly quantities larger than 50 can be reviewed.

M. Cazaubon discussed the new law passed about bicycle safety. The law goes into effect March 1, 2002. The committee wants to send a letter to the media addressing the issue. The Louisiana Highway Safety Commission has given Think Fast and Safe Kids \$30,000 for the purchase of helmets to distribute to indigent children in Louisiana. The law affects children age 12 and under. It was not certain whether or not children age 12 are included. Cazaubon said to assume 12 year olds are included to be on the safe side.

M. Cazaubon reads the draft for aggressive driver law. Mr. Falgout talked about the draft and the language of the law was discussed. Other state's education regarding aggressive driver laws were discussed. The committee wants to see how other states address the situation.

A letter was received regarding Elm Street in LaPlace which was found to have abnormal accidents. A traffic signal will be installed. M. Cazaubon questioned the best way for the DOTD to stay on top of the Elm Street Project. Mr. Shirazi of the LADOTD said they will give updates.

Capt. Diaz discussed the sub grants that did not meet the qualifications for funding. B. Thompson explained why some of the items could or could not be funded. The grants that could not be approved were given an extension to rework their applications and resubmit them.

Lady of the Sea application needed to be amended. An outline of their project was distributed. SafeKids Safety Circus at the Cutoff Youth Center will be held May 4th. Motion to approve Lady of the Sea sub grant moved D. Matherne second C. Poche . One stipulation is the reflectors must have LHSC concurrence. Motion was passed.

M. Cazaubon discusses the Bicycle Helmets. Our Lady of the Sea and Thibodaux Regional programs has seen an increase in their participants. They do not screen children for qualifications other than age. The problem is that \$30,000 will not purchase a lot of helmets. Cazaubon is looking into getting funding from the Gheens Foundation. The Foundation meets quarterly so the application must be submitted February 22nd. The application was for \$15,000 to help purchase about 2,000 helmets at the price of \$6.99 per helmet.

St. John the Baptist resubmitted their grant application. G. Maurin discussed this issue. It is a combined enforcement and education policy. The schools were real receptive of the officers coming into the schools. It is for two radars and materials to be used in connection with high school drivers' education courses. The courses are two hours training from the officers. It also discusses the use of fatal vision and gadgets. The application is for \$7,000. Motion to accept moved by D. Matherne second by C. Poche. The sub grant application was approved.

M. Cazaubon said there might be extra money in the budget. She will get back to the committee.

Submitting the new application to LHSC was brought up for discussion. The committee needs to revise 13 goals based on LHSC statistics for the region. Capt. Diaz suggested filing an application. A committee needs to form to discuss the issues before the March 21st meeting. T. Diaz, R. Mitchell, C. Authement, and Martha agreed to sit on the committee.

Safety concerns to the DOTD are discussed. Positive things have come about such as the LA Hwy 20 construction and Elm Street project. Capt. Mitchell mentioned Hwy 308 at Manchester Manor the main problem being LA 664 identified as St. Charles. It is creating problems by lack of lighting and diverting traffic to other areas. Mr. Falgout mentioned concerns with Hwy 308 and Hwy 1 Lafourche Crossing. There are concerns about the ability to evacuate residents during flooding events.

There was discussion of the construction that will take place on LA Hwy 20.

Capt. Mitchell thanked Chris Authement for his response concerning school buses in Terrebonne. He noted that over 700 people were trained in incident management to date. Law enforcement officers should talk to their bosses for support to create Traffic Task Force. Two officers can comprise the Task Force for each law enforcement division.

Capt. Mitchell said there were two pedestrian fatalities that occurred at Mardi Gras parades. Next year we really need to do education on this issue. Resources are strained during the Mardi Gras holiday. Deaths should not occur during Mardi Gras parades.

B. Canfield remarked on comments by Phil Jones that a special session legislation will be addressed about the loopholes in the changes in DWI laws.

There are two bills in Congress to reinstate all of the money being cut from the highway program. Send a letter to the Congressman.

Booster Seat Program March 1st in New Orleans and March 2nd in Baton Rouge, They distribute 500 booster seats. Lafourche Parish has their 500 seats. Contact Bridgette for further information.

There being no other business to discuss, Greg moved, D. Matherne seconded, that the meeting be adjourned.

It was moved by L. Alcorn, seconded by L. Landry to accept the minutes of the meeting held on February 21, 2002. Motion carried.

Capt. Diaz stated that the Safe Community is still in the funding process of the NHTSA grant. He said that there have been several meetings and discussions on the money will be spent. A large portion of the money will go toward enforcement of targeting impaired drivers between the ages of 21 through 34. He informed the Task Force that so far seven (7) law enforcement agencies have signed on to participate with the program.

Discussion ensued on the new intoxilizers that may be needed for the enforcement of the NHTSA grant. Capt Diaz said that a letter will be sent to applied technology asking what the future looks like for the intoxilizers and which agencies they will supply them to.

M. Cazaubon said that Bob Thompson informed her about DWI checkpoint setup equipment that is available through the LHSC. She said that the only area in the South Central Safe Community region that LHSC has contacted is Lafourche. M. Cazaubon discussed what was included in the setup and the costs involved. There was discussion about possibly purchasing one or more sets with grant money.

M. Cazaubon said that the state had purchased portable breath testers and that the State Police can no longer use the testers. Capt. Diaz informed Ms. Cazaubon that no one can use the testers. Ms. Cazaubon said that LHSC will give the testers away. Mr. Diaz said that the testers could be used for other programs. He said that the PASS officers in the schools could use the testers if a child shows up drunk in order to see if the student was drinking alcohol. The testers could be used for the inmate work release program to test inmates coming in from the work environment. Ms. Cazaubon said that in order to request the testers from the state, a letter needs to be sent requesting the testers. M. Cazaubon will write a letter for the Safe Community Program requesting 100 testers.

M. Cazaubon explained that there are three (3) graduate students at NSU working on a class project. She said that the students are looking at the DWI problems. The students are conducting background research and will come up with information that may help to design a media campaign for the NHTSA grant.

Discussion ensued about the excerpt from the Code of Ordinances for the City of Alexandria in regards to the 21 and under law that goes beyond what the current state law requires. It was suggested by J. Boudreaux that M. Cazaubon try to get a guest speaker from the City of Alexandria to attend the next meeting. He also suggested that she develop a sample resolution for the next meeting.

Discussion ensued on the Media Campaign. Capt. Diaz asked M. Cazaubon to put together a proposal for the next meeting on items that could be purchased.

There was discussion on the aggressive driver's legislation and education.

There was a suggestion that booster seat education would be a good area to spend some of the \$11,000 remaining in the subgrant fund.

M. Cazaubon updated the Task Force on the grant application submitted to the Gheens Foundation for bicycle helmets. The application will be reviewed in June.

Capt. Diaz reminded the Task Force that the Traffic Summit is scheduled for Wednesday, May 1, 2002, in the Century Room at Nicholls State University.

M. Cazaubon informed the Task Force about another speeding grant that just came out from NHTSA. She also discussed next years Safe Community Grant. Discussion ensued.

Capt. Diaz discussed Highway Funding Projects. He suggested drafting a letter to our legislation showing support for legislation to restore the Tea 21 funding.

Capt. Diaz introduced Ms. Lou Lyons. Ms. Lyons discussed the conditions of LA Highway 1 where she recently lost her husband in a traffic crash. The area she spoke of was near Port Fourchon Road. Mr. Diaz thanked Ms. Lyons for her bringing this concern to the Task Force. He also suggested that she voice her concerns to the LA 1 Coalition.

Capt Diaz introduced Ms. Penny Cuneo and Ms. Kayla Guerrero of the Office of Public Health. Ms. Guerro stated that she is the Emergency Response Coordinator for Region 3.

G. Falgout said that Prom Night is scheduled at Lutchter High School for April 8th at 8:45 a.m. D. Cunningham said that Operation Prom Night will be held at Vanderbilt High on April 18th.

Discussion ensued on the G.P.S. purchase.

Sgt. Cunningham requested that a letter to LA DOTD be prepared from the Safe Community Program requesting double yellow stripes and signage on LA 24 between LA 57 and LA 661 for about a ¾ mile stretch (between Grand Caillou and Howard off of Main St. overpass).

Concern was raised about having no speed limit signs on Highway 311 from Hollywood Road to the Overpass.

J. Boudreaux informed the Task Force that the LA Emergency Preparedness Association will come to Houma June 2nd through 6th. He said that you can get the Workshop Agenda if you go to LEPA.org.

Mr. Lanny Soudelier who represents the Driving School Association of Louisiana discussed his efforts in working with the legislators in coming up with new legislation.

D. Naquin said that representative from Federal Highways will be down from Washington on April 18th and 19th. He said the FHWA is conducting a study of best practices for highway safety. FHWA will be down to look at the traffic stats program.

It was suggested that DOTD or law enforcement officials pull out the books to check the site that Mrs. Lyons spoke about. Capt. Diaz stated that he plans to take a ride out to Port Fourchon and then possibly generate correspondence to whoever is responsible for structure.

There being no other business to discuss, D. Cunningham moved, L. Landry seconded, that the meeting be adjourned.

It was moved by D. Cunningham, seconded by L. Landry to accept the minutes of the meeting held on March 21, 2002. Motion carried.

Ms. Mary Stringfellow of Federal Highways said that she and others from Federal Highways feel that the Safe Communities is doing a great job. She said that they would like to replicate the success that the Safe Communities is having in other parts of the state. Ms. Stringfellow said that members of the Safe Communities Coalition will be interviewed today to try to find out what makes the South Central Safe Communities successful.

Chairman Diaz introduced Ms. Jamie Naquin from Nicholls State University. Ms. Naquin has a class project that she worked on with Capt. Mitchell of Troop C on their tailgating program. Ms. Naquin was contacted to help the Safe Communities out with a media outreach for the NHTSA grant. Ms. Naquin said that the class will put together a training video on Drinking and Driving. The class is working on a survey and the data will be analyzed to determine what the target market for DWI education is. Some rough results from the surveys are that they are noticing that family is the most important factor in people's lives, so targeting the emotional side of how DWI affects families is a possibility. Education is needed on what the costs of DWI actually are. Many of those questioned really do not know. When asked about perception of the amount of crashes related to DWI, most people

estimated low. The average is 50% but in reality it is really about 90%. A presentation will be made to their class on their final project on May 7th and others are welcome to attend.

Chairman Diaz introduced Ms. Annette Knobloch of the William Carey School of Nursing. She explained that her students are participating with the Safe Kids in the Child Safety Seat checks, mainly in the New Orleans area. She also had one student participate in the "Boost America Tour" at Jefferson Parish. There were approximately 600 vehicles that went through. If anyone would like help in these types of safety events, please let her know. Ms. Knobloch asked that advance notice be given in order to work the programs into the school schedule. She said that she could also help the Safe Communities get in touch with other nursing schools.

Chairman Diaz introduced Capt. Mitchell. Capt. Mitchell stated that so far there have been 14 fatalities this year in the Troop C area, and over ½ of them are under the age of 18. He stated that something needs to be done to keep children out of the streets during Mardi Gras. Capt. Mitchell said that this summer Troop C is going to take a zero-tolerance stance on not wearing seatbelts. He said that the mock crash yesterday at Vandebilt High School was great. More of these programs need to take place especially in the public schools. Capt. Mitchell stated that through the Traffic Stat Program, Troop C identified that in some places over 65% of the crashes were happening because of "following too closely". He said that Dr. Lefleur's students were challenged last year to come up with a program to target tailgaters. Capt Mitchell showed the Task Force some of the concepts that the students came up with which will be implemented throughout the year.

Matt Trahan, Public Information Officer of the Louisiana State Police gave a presentation on Tailgating. Mr. Trahan explained how the State Police identified the tailgating problem by looking at the data. He said that the alligator with the LSP uniform was already the Troop C association mascot. This lead to the idea to use it in the Tailgater campaign "Don't be a Tailgator". He said that a local billboard company was contacted and graciously donated the banners and billboard space. For enforcement, Capt. Mitchell purchased stop watches for all troopers to actually time the 2 second rule. The public was informed ahead of time that the trooper would be timing people and writing tickets for following too closely. Mr. Trahan said that the State Police wanted to do more with the campaign so they contacted Dr. Beth LeFleur at Nicholls State University to work with them. The students from three classes had this as a class project. The class not only developed items for this campaign, but also gave the State Police strategies on when and how to use the campaign. Some of the concepts that the students came up with were cartoons, costs of tailgating, leave it at the game, just 2 seconds & gators kill their prey.

Capt. Mitchell introduced Fire Chief Jerry Gautreaux. Chief Gautreaux explained that the fire department approach to the issue of emergency vehicle lights and sirens have greatly increased in the past few years. Every firefighter who wants to put an emergency light and siren in their private vehicle has to take a 16 hour training course. Mr. Gautreaux informed the Task Force that Fire Departments will take a step back and only allow those vehicles that are primarily responsible for the incident to respond with their lights and sirens. Any other vehicles responding to the incident may not put on their lights and sirens.

Discussion ensued on the NHTSA grant. Chairman Diaz stated that for St. James and Assumption Parishes the intoxilizer machines have not yet been upgraded to the new Cobra system. M. Cazaubon contacted Applied Technology in Baton Rouge and they will supply the upgraded machines if the request is put in the form of a letter to them. M. Cazaubon said that she was told that after July 1st they should be able to let us know who will have the new intoxilizers. The current intoxilizers that are in use now are good through January 1, 2003.

Chairman Diaz said that under the Enforcement Campaign of the NHTSA Grant a sub-committee will need to be formed to determine the disbursement of funds available for the grant.

Chairman Diaz stated that for the Media Campaign, the Commodity costs numbers are not complete yet so this will need to be tabled until the next meeting.

Bob Thompson stated that LHSC is asking NHTSA for special permission to use the extra portable breath testers for non enforcement issues. He said that he should know more next week.

The aggressive driver issue will be tabled until the next meeting

Chairman Diaz stated that the current subgrant awards need to get their programs started. The deadline for submitting invoices is September 30, 2002.

Chairman Diaz announced that the Traffic Summit is scheduled for May 1st at Nicholls State University. M. Cazaubon said that SCPDC was able to get a larger room so the Traffic Summit will be held in the Student Union Ballroom instead of the Century Room.

Chairman Diaz informed the Board that a speaker was not able to be lined up from Alexandria to speak about how they went about passing a parish ordinance to have a 21 drinking age law. He said that they will continue to try to have someone attend one of the future meetings.

Chairman Diaz discussed the Buckle Up America Strap In Campaign. He said that this campaign is funded through the LHSC. On May 20th a public press announcement will be made to announce the participating agencies. Capt. Mitchell said that the funding will run through the summer. Chairman Diaz said that the funding covers the time that the Safe and Sober Campaign did not cover. He Diaz said that in Lafourche Parish it was noted that in the morning hours the seat belt compliance rate was low. Lafourche Parish has started doing enforcement in the morning hours from 6 a.m. to 8 a.m.

M. Cazaubon said that the striping on Hwy. 24 is on order. Lyle Leblanc said that an additional sign has already been added south of the intersection. He said that the striping crew is scheduled to come soon to re-stripe this area and other intersections in the Houma area. There was a request for Mr. LeBlanc to look at the area at LA 312 between Honduras and Bond. Mr. LeBlanc stated that the signal will be upgraded at LA 315 and LA 182 which is near the golf course.

Mr. Soudelier of L & L Driving School stated that there are no center lane only signs on Martin Luther King Blvd. He said that people do not know how to use the center lane.

Capt. Mitchell congratulated the committee on all of its achievements which is due to all of the agencies working together.

Chairman Diaz stated that the information that was presented by Ms. Lyons at the last meeting is under investigation and the matter will be tabled until the next meeting.

Chairman Diaz asked if there are any upcoming events in the region.

Lanny Soudelier stated that the Driving School Association meeting will be held this weekend in Baton Rouge. The Association will be discussing needed legislation in the year 2003.

Capt. Mitchell stated that a DWI checkpoint will be held on the last weekend in April by Troop C and the local police agencies. Chairman Diaz stated that Lafourche Parish is thinking of conducting a DWI checkpoint in Bayou Blue in the near future.

Chairman Diaz said that on May 3rd is the Lady of the Sea Safe Kids.

Sheriff Waguespack announced that the first Crawfish Festival will be held this weekend in Assumption Parish at the No Problem Raceway.

The Terrebonne Parish Chapter of the American Cancer Society Relay for Life will take place tomorrow night at the NSU stadium in Thibodaux.

M. Savoie stated that May 19th – 25th is EMS week.

ADAC will be hosting the annual Joe Deantrea Run in June at the Jim Bowie Park.

There being no other business to discuss, it was moved by D. Cunningham to adjourn. Motion carried.
