Minutes of previous meeting did not need to be approved. February meeting is the Traffic Summit Meeting at Nicholls State University.

Capt. Mitchell discussed filling the vacant board positions. Vacancies filled as follows: Assumption Parish—Bruce Prejean, St. Charles Parish—John Pollard and Jan Troxler, Terrebonne Parish—Darryl Cunningham. Motioned by Chris Authement and seconded by Jim Hogue. Motion passes. A letter will be sent to everyone about the Executive Board positions. A letter of inquiry (as to their status) will be sent out to board members if they miss two consecutive meetings. Moved by Royce Doucet and seconded by Lou Landry. Motion passed.

Vice Chairman elections: Jim Hogue and Greg Maurin are nominated. Greg Maurin is the new Vice-Chairman.

Sub-grant applications had been re-opened until January 30, 2003. Nine applications have been submitted. A handout was given pertaining to the sub-grant applications. There is \$40,000 budgeted for sub-grants. Bayouland YMCA and St. Charles School Board could not be funded. It was recommended that the following agencies be funded: Our Lady of the Sea, St. James Parish Sheriff, St. John Parish Sheriff, Thibodaux PD, Lafourche Parish Sheriff, Assumption Parish Sheriff, and Houma PD. There is a motion to reduce the requests to 80% of funding in order to fund all remaining agencies. Motion to approve sub-grant amendments was moved by L. Robinet and seconded by L. Landry. Motion passed.

The NHTSA 21-34 year old grant and Rational speed grant were mentioned. If some projects fall under these two areas then monies can be appropriated. This way the agencies can receive additional funding besides just the sub-grant dollars. Materials can be purchased under these grants.

The Task Force can supplement Rail Safety (St. John Parish). The Task Force could use this as a media campaign. Media money can help support it.

L. Williams mentioned that the SCPDC staff discussed putting into the sub-grant contracts a clause stating that at any time the grantee is subject to a site inspection. This is to ensure that the grantee purchased items listed in contract and are items are located were stipulated.

Agencies should share equipment. Capt. Mitchell said this should not be a problem. Everyone does not need to buy the same equipment. The equipment can be loaned out as needed. Typically agencies have been good about this.

Capt. Mitchell brought up the issue of the meeting locations. Meeting in different locations hasn't been fruitful. Turnout is better when meetings are at Troop C. Meetings will rotate every 3 months with the main location at Troop C.

The Executive Board will meet quarterly before the regular meeting. The Executive meeting will be 30 minutes to 1 hr before the regular meeting.

The Traffic Summit Meeting will be held February 18, 2003 at Nicholls State University. Speakers have been lined up. The Traffic Summit will replace the February meeting. Continental breakfast and lunch will be provided. The presentations start at 8:30am. There are some RSVP forms on the table. If you have any questions please contact Leslie at South Central Planning

(851-2900) or <u>Leslie@scpdc.org</u>. All information can be found on the South Central Planning website (www.scpdc.org) under Safe Community. We have over 100 participants signed up with an array of speakers.

Goals and Objectives for the year should be prepared for the March 20th meeting. Capt. Mitchell said to give him an idea of the direction you would like the Task Force to go. A sub-committee will be appointed to review the goals and objectives.

Capt. Mitchell would like to add an agenda item to the regular Task Force meetings. The item is Parish Reports. Each Parish should give an update to things going on in the Parish.

- L. Williams and M. Cazaubon discussed Public Relations. The newsletter is on the website. We would like for Task Force members to provide information for the newsletter. We have been getting some good press coverage. Newspapers will publish press releases if given to them provided they have space. Everyone likes the new newsletter, which has replaced the meeting notice.
- L. Williams asked if the new DOTD form was adequate. Capt. Mitchell believes it looks okay. A letter will follow up the DOTD requests. Written documentation works better than verbal communication only. Capt. Mitchell would like to avoid the DOTD people feeling they are ambushed at meetings. Crash documentation is very helpful to submit with request.

Cathy Holmes offers anger management classes. She is willing to offer classes. She is willing to do a presentation at the March 20th meeting. This was brought up in relation to the Aggressive Driving proposed legislation.

Alcohol law just passed in St. John Parish. Alcohol cannot be served from 2am to 6am.

Bob Thompson gave an update on the Louisiana Highway Safety Commission. Ben Pressburg came with Bob. He gave an introduction of himself and responsibilities at LHSC.

Capt. Mitchell gave a Troop C report.

Capt. Mitchell stated that a position is open on the Executive Board. Vacancy: Terrebonne (1 spot). Lt. Greg Hood was nominated to fill the spot. Moved by D. Naquin and seconded by G. Falgoust. Motion carried. Lt. Hood is replacing Darryl Cunningham.

Leslie gave an update on the 21-34 year old grant. Rochelle St. Marie is still working on the manual. Things are moving nicely.

The overtime campaign is scheduled for June 20th to July 6th (50hrs) for DWI enforcement.

Aggressive Driver legislation was spear headed by Gerald Falgoust on behalf of the Task Force. Senator Reggie Dupre is sponsoring the legislation.

Capt. Mitchell gave an update on the rational speed grant. Capt. Mitchell along with SCPDC and the MPO met with the contractor on the project. The identification process is underway.

There is a proposed 211 system (House Bill 1183). There are some concerns from Task Members. This is an OEP issue. There are concerns about how emergency calls will be routed.

St. James announced Prom/Graduation Night at St. James High for May 12th. Lafourche announced a Mock Crash in South Lafourche for May 9th; several DWI checkpoints to be later mentioned. No one else had anything to report.

Prior to the meeting a sub committee met to discuss the goals and objectives of the Task Force for the year. Capt. Mitchell would like to see the website and Traffic Summit activities expanded. Chris Authement suggested that there is a problem with School Bus Safety (kids waiting for the school bus). Maybe the Task Force can do an educational component to address the issue. Bruce Prejean stated that Assumption Parish Sheriff's Office would begin enforcement for insurance checkpoints and water safety programs. D. Naquin that some safety programs should be expanded (bike safety, Tailgator, child seat checkpoints). The local legislators should be more involved. The Task Force should work on getting them at more meetings. T. Diaz mentioned the problem with ATVs on the highway. Maybe find some funding to address this issue for an educational component.

The media campaign has budgeted \$6,000. There is \$3,000 for equipment. The remaining \$3,000 is available for different types of media. This will be tabled until the summer.

Additional sources of funding can be looked into for funding Railroad Safety in River Parishes.

Jim Hogue gave a report about ATVs and finding sources of funding. He will look into getting a speaker for the next meeting.

DOTD gave an update on the previous safety concerns. The Task Force started having a yellow form to fill out to voice any safety concerns.

Betsey Williams gave an update on the Tailgator campaign.

Gerald Falgoust gave an update on the OEP Task Force.

Kevin Belanger with SCPDC gave a presentation about what South Central Planning & Development Commission's role in the six-parish region.

Matt Trahan discussed Operation "Summer Heat" in the Troop C Area. It is the name of the summer campaign. It covers seatbelts and insurance checkpoints.

Martha gave an update on the 21-34 year old grant. Things are going real well. NSU is putting together the training video. They have it scripted and will begin filming next week. Rochelle St. Marie is working on revisions to the manual. NHTSA has extended the grant until June 2004. Two trainers will perform the actual training. We are still waiting on NSU to get feedback on the media campaign. The overtime campaign is scheduled for Labor Day weekend (50hrs) for DWI enforcement. The Labor Day enforcement was called Blue Talon. It covered DWI and occupant protection. There is money in the budget for two more overtime campaigns.

Leslie gave an update on the media campaign. We have \$3,000 in the budget to spend by September 30th. It was suggested to reorder items. There is a suggestion for rulers, pens, and pencils.

There was discussion about the 1-day child safety training. There is a lot of interest in child safety issues. Capt. Mitchell mentioned at an earlier meeting that he would like to have a training session for officers to learn how to properly install child safety seats. Jim Hogue added to the discussion. It is difficult to get volunteers to participate.

Bob Thompson stated that for the upcoming year that it is necessary for officers to be trained if participating in OP enforcement. Matt Trahan expressed Troop C's interest in having training sessions at Troop C.

Gerald Falgoust gave an update on the Aggressive Driver legislation. It was passed through the Senate but was defeated in the House. The status is uncertain. It was sent for further study.

Martha gave an update on the rational speed grant. The process is moving along. Belanger discussed the ticket tracking software developed by Ryan to help local law enforcement.

There was discussion about improving the Task Force website. Ryan said he could work on the website so that Leslie can make the updates herself. Progress is still underway.

Jim Hogue gave an update on OHV. The meeting in Baton Rouge was cancelled. He discussed the last sub-committee meeting. The next meeting is scheduled for September 24^{th} at South Central Planning at 10 am.

Parish reports were given. Gerald Falgoust mentioned that St. James Parish had a trail derailment with Hazmat issues. The 641 Railroad crossing is in bad condition but will get repaired in 2 weeks. The OEP Task Force was essential because of the Safe Community Task Force and South Central Planning. The OEP Task Force received \$100,000 extra money in funding.

Jim Hogue gave an update for Lafourche Parish. Jim gave an update about the ATV sub-committee meeting that was held on the 12th. No other parishes had anything to report.

There was a letter sent to Kevin Belanger from St. Charles Parish requesting a letter of support from the Task Force. On Hwy 90 bridge crossing Davis Pond Freshwater Diversion there is a problem with people parking on the shoulder near the bridge. People are also fishing on the bridge. St. Charles Parish would like to see a no fishing sign. Darren Naquin expressed his concern that something needs to be done. Motion for letter of endorsement is on the table. It was moved by D. Naquin and seconded by G. Falgoust. The motion passed to send a letter on their behalf.

Leslie informed the Task force that the new grant year starts October 1st for the fourth year. More information will follow about the sub-grants later.

Kevin Belanger informed the group that Wal-Mart might be contributing some funding to the Task Force. We are still waiting to hear if we received the money. There is the possibility of up to \$35,000 additional funding to support sub-grants.

Leslie asked everyone to check the email list for correct email addresses.

Leslie gave an update about the State Farm grant. The Task Force received a grant for \$1,800 from State Farm to purchase new crash dummy costumes. The costumes were ordered and will take 4-6 weeks to come in.

No one from DOTD was present. There was a conflict in meetings. There were two concerns from L. Landry. LA 3127 and LA 18 have terrible road surfaces.

Capt. Mitchell thanked Todd Diaz for being the chairman for the past three years. He hopes to do as good a job as Diaz. Todd Diaz was awarded a plague for his dedication.

Capt. Mitchell stated that several positions are open on the Executive Board. Each parish has 3 positions and an alternate plus 3 at large positions. Nominations are open for two weeks. The Executive Board will meet in two weeks (February 6th) to discuss sub-grant applications, Vice Chairman position, and filling of the vacant spots. Vacancies: Assumption (1 spot), St. Charles (1 spot), Terrebonne (2 spots). Capt. Mitchell was appointed to Terrebonne position. Moved by G. Falgoust and seconded by L. Landry, the motion passed. There is now 1 spot vacant in Terrebonne. Vice Chairman nominations are James Hogue III and Greg Maurin.

Sub-grant applications have been re-opened until January 30, 2003. Seven applications have been submitted thus far. A handout was given pertaining to the sub-grant applications. There is \$40,000 budgeted for sub-grants.

A total of 1,240 bicycle helmets were bought through the Gheens Foundation grant (\$4,900). Linda Savoie will be providing the educational component and distributing them via the six-parish area Head Starts. She has already visited some of the local Head Starts. Linda is waiting to hear from St. Charles and Assumption Parishes to set up presentations.

Linda is doing a child safety seat checkpoint at the Wal-Mart in Thibodaux on Saturday, January 25th. If you would like to volunteer please contact her. Jim Hogue mentioned that parents can call for an appointment to get their safety seats checked.

Martha gave an update on the 21-34 year old grant. SCPDC is looking into contracting with Nicholls State University to create the video and public service announcements. An independent consultant (Everett Miller) will do the training. We are waiting to get these contracts back. By next month, there will be more information.

Gerald Falgoust discussed aggressive driving. The educational component for Aggressive Driving should be anger management classes. The final draft of the proposed aggressive driving law has been completed. A final copy was handed out to those at the meeting. G. Falgoust asks that the proposed legislation be submitted to Col. Champagne. Moved by G. Falgoust and seconded by J. Hogue. Motion passed.

G. Falgoust suggested that the Task Force send a letter of support to Col. Champagne. It should be a letter pertaining to the aggressive driving law and a general letter of support for Col. Champagne's efforts. Everyone on the Task Force should sign the letter. Moved by G. Falgoust and seconded by L. Robinet. Motion carried. A letter can be sent to our legislators also.

Martha gave an update on the rational speed grant. It is funded through the Federal Highway Safety Association. It is a two-year project. The community needs to know how the grant will affect them. Education and public awareness has to change the community's attitudes about speed. The grant compares enforcement with education and public awareness. Street segments will be compared throughout the six-parish region. Recommendations will be made based on data collection if street/road speeds should be changed (increase, decrease, or remain the same).

- R. Mitchell gave an update on the Zero for December campaign. There were 4 fatalities (3 of the 4 were age 17). There were 7 fatalities in the previous year. The campaign will be done again in 2003. Troop C is still analyzing statistics from the campaign. January 15^{th} April 15^{th} the State Police will be involved in a Litter Campaign. There will an enforcement and educational component.
- L. Robinet asked for some temporary signage at Elm St and La 44 due to continuous accidents. The signal light and turn lane is letted for December 2003. There appears to be another obstruction of sight. DOTD checked out the concerns and didn't see anything. They will go out again to check the obstruction.

There was some trouble with the evacuation route at US 90 and 310. People must cross westbound traffic to go eastbound. Traffic was backed up to Des Allemands in St. Charles Parish. There will be a new evacuation plan. DOTD will look into this problem.

February 3-12th –The Galliano Bridge will be closed 7am –4pm. It is under going deck replacement. Bridge will also be under construction.

Danny Smith gave an update on the Terrebonne Parish DWI court.

Darrin discussed the rollover simulator. It will run roughly \$15,000. Darrin was requesting to use some of the subgrant money to purchase the rollover. Darrin will research costs and get more information. The Task Force should look for additional funding from senators, insurance companies, etc. Leslie can draft a letter asking for assistance. There was discussion from the Task Force members.

Angie gave a brief discussion about merging the enforcement contracts with Task Force contract to be handled by SCPDC.

Kevin Marcel gave an update on Zero for December. Campaign was successful. There were 3 deaths. However only 1 accident was alcohol related.

Commodities have arrived. They need to be sorted. There was a problem with the t-shirts. They had to be sent back and redone.

The sub-grant contracts have gone out. Make sure you have received your grant, signed it, and returned it to SCPDC. We received additional funds for sub-grants.

Leslie did the Student Leadership presentation at NSU. It went very well. NSU is looking forward to the new partnership.

Tisa will be at the March meeting with some students. We are still trying to move forward with this aspect.

Tanner introduced himself and asked for everyone to do the same.

Greg Maurin informed the Task Force that he and Mr. Robinette met with Mr. Belanger and Mr. Magee to get a re-commitment from SCPDC on the Safe Community Program. He said that SCPDC has committed to continuing the Safe Community Program.

The next item discussed was commodities. Mr. Magee stated that all of the commodities have been picked up. Mr. Marin asked Mr. Magee to review the budget to see if there is extra money to purchase commodities.

An update was given by Mr. Maurin on the Lifesavers Conference.

Mr. Magee updated the Task Force on the progress of the traffic summit. He stated that the afternoon session will be removed. He explained that this is being done to shorten the day to try to encourage people to stay for the entire program. He also updated the members on the speakers he had confirmed to date.

The next item for discussion was an update on the sub-grants. Each grantee was given an opportunity to give an update of their sub-grant. Also time was allowed for parish reports.

Mr. Canfield provided handouts and discussed same. He discussed bills in the Legislature regarding highway safety. One of those bills concerned the use of cell phones in school zones.

An update was given on the Terrebonne Parish Drug Court. An update was also provided regarding a PowerPoint presentation and prom night film shown at six area high schools. Next year the Civic Center will be used to conduct a mock crash which will be presented to high school juniors and seniors.

Mr. Dennis Babin and Ms. Shalanda Cole of DOTD attended the meeting to inform the Task Force of the Safe Routes to School Program. Mr. Babin gave a powerpoint presentation which highlighted the need for safe routes to school, the amounts available for funding, types of projects eligible, and application deadline information.

It was moved by Chris Authement, seconded by Craig Poché to approve the minutes of May 17, 2007. Motion carried.

The upcoming meeting schedule was discussed. The dates are as follows: November 15, 2007, December 20, 2007 (Executive Committee to review mini grants), January 17, 2008, and March 20, 2008.

Melissa Menuet discussed the changes that were made to the 2008 Grant Guide and asked that if anyone had any recommended changes or questions that they contact SCPDC. The mini grant applications are due Monday, December 10, 2007. She notified everyone that a Grant Workshop will be held on November 7, 2007 at SCPDC.

Melissa Menuet notified the Task Force that before Leslie Williams had left SCPDC both she and Capt. Greg Hood pursued ATV funding through the LHSC. She stated that they were successful in obtaining \$15,000 in funding for ATV education. She stated that \$15,000 of the \$46,000 for mini grants in the 2008 contract is targeted towards education in keeping ATVs off of the highways.

The Traffic Summit evaluation results were distributed and discussion ensued on the MADD presentation.

Melissa Menuet stated that all subgrant invoices have been submitted to SCPDC. She said that Terrebonne Parish Sheriff's Office will not be able to spend \$2,400.00 of the money that they were awarded. She asked the Task Force if they wanted to purchase commodities with the money that was not spent. She stated that a budget amendment would probably need to be approved by LHSC to do so.

It was moved by Capt. Greg Hood, seconded by Linda Savoie to move the approximate \$3,000 that was not spent by TPSO to purchase extra commodities. Motion carried.

Under Parish Reports, Sgt. Antoine Rodrigue of the Lafourche Parish Sheriff's Office displayed a ResQ Disc which is a life preserver. He asked if the disc would be an eligible item to be purchased with Safe Community funds.

Lanard Robinet of St. John Sheriff's Office stated that after five (5) years of requesting a traffic signal in St. John Parish it was finally installed.

Greg Maurin of St. John Sheriff's Office spoke of a train/vehicle fatality that happened earlier in the month. He said that on October 30th & 31st there will be a railroad investigative class in LaPlace.

There being no other business to discuss, the meeting adjourned.

It was moved by Lanard Robinet, seconded by Craig Poche to approve the minutes of January 24, 2008. Motion carried.

The upcoming meeting schedule was discussed. The dates are as follows: May 15, 2008 and September 18, 2008 at Troop C. The Traffic Summit will take place on July 17, 2008.

Melissa Menuet discussed information she received from Addie Smith of the North Central Alliance Partners in Prevention on an approach they use to encourage designated drivers. Ms. Menuet provided art work for stadium mugs that Ms. Smith allowed use of if the South Central Safe Community Task Force would like to work towards a similar type of program. Ms. Menuet stated that local bars and restaurants in the North Central Alliance Partners in Prevention area allow those individuals who enter into the restaurant or bar with the mug to have unlimited soft drink refills. The mugs would be given to individuals at sobriety checkpoints who were not drinking

alcoholic beverages. The committee liked the idea and directed Ms. Menuet to get quotes on mugs and contact bars and restaurants to see if we could get participation. Ms. Menuet asked if anyone had any specific bars or restaurants in their parishes who they felt would be interested in participating. Sphars in Des Allemands, Houma and Thibodaux was suggested as a good restaurant to contact.

Melissa Menuet stated that there is a request by Troop C to purchase a panda mascot costume. Gilbert Dardar discussed the Buckles the Bear mascot. He said that he borrowed a costume for Mardi Gras and the kids loved it. He stated that the costume cost \$600.00 which includes the head and arms. Melissa Menuet asked if the Task Force would be willing to purchase the costume with commodity funds. Discussion ensued.

It was moved by Chris Authement, seconded by Craig Poche to allow \$600.00 of the funds allocated for commodities to be spent to purchase the panda costume for Troop C. Motion carried.

Under Parish Reports, Antoine Rodrigue reported that Lafourche Parish will conduct a DWI checkpoint on April 18th. He also stated that a mock crash was conducted in the Parish. Steve Tullis reported that NSU conducted the Fatal Vision program with the golf cart in the past week. Gilbert Dardar reported on the Mock Crash demonstration which was held in Terrebonne Parish. He also showed the Task Force the photo which was taken by Picture Parlor of all law enforcement agencies. Greg Maurin spoke on the progress of St. John's subgrant. He said that the Traffic Division conducted stops to check for child safety seat compliance and the success in getting the car seats to those in need.

Hadi Shirazi reported that Terrebonne Parish upgraded to the new LED traffic signals. Lyle LeBlanc of DOTD stated that Lafourche Parish is completely upgraded but Terrebonne Parish has approximately another 20 signals to be updated. Mr. LeBlanc stated that this needs to be completed in order to proceed with ITS. He said eventually intersections will be monitored and the timing will be able to be changed from a remote location.

Greg Maurin asked if anyone in the region had traffic enforcement cameras. Lyle LeBlanc stated that the traffic enforcement cameras are not done on state routes.

Discussion ensued on brick mailboxes on state right of ways.

Gilbert Dardar stated that on Saturday, April 5th Troop C will conduct its 4th Annual Open House from 11 a.m. to 3 p.m. He said that the open house is open to the public.

Melissa Menuet stated that she has booked the Century Room at NSU for the upcoming Traffic Summit. She informed the Task Force that the Century Room was the only room available at NSU due to the Ballroom being under construction. The Century Room will only hold 75 comfortably. Ms. Menuet also informed the Task Force that she has also booked the Terrebonne Parish Main Library which can hold up to 99 people comfortably. She asked if anyone had any objections to the Traffic Summit being held at the Terrebonne Parish Library. The members agreed that the Terrebonne Parish Library will be a good location.

Melissa Menuet discussed guest speakers for the upcoming Traffic Summit.

Betsey Tramonte informed the Task Force that she is now employed as the Safety Specialist for FHWA. She reported on the FHWA rural safety initiative which is money available for safety improvements for rural roads. The money is targeted towards the delta parishes and \$15 million is available nationally. She informed the Task Force that a workshop will be held on March 25th at the Louisiana Transportation Research Center on the LSU campus. She said if anyone is interested in attending to contact Spencer at 225-767-9717.

Karla Sibille reported that she has taken Betsey Tramonte's place at Operation Lifesavers but is also still conducting her current duties with DOTD. Ms. Sibille suggested that Ms. Menuet contact Redflex Traffic Systems to be a presenter at the Traffic Summit. She stated that work zone awareness week is April 7th through 11th and DOTD will be participating. A cone memorial will be set up in front of DEQ headquarters.

The final item on the agenda was the ATV Subcommittee Report. Alicia Toups presented the PowerPoint/video presentation which will be conducted in the schools.

Discussion ensued on the number of ATV accidents that were on public access roads. Ms. Toups requested assistance in getting local numbers to include in the presentation. Ms. Tramonte asked if the students would be told in the presentation that it is also illegal to ride ATVs on railroad tracks. Ms. Toups stated that it would be. There was discussion regarding ATV fatalities on private property as well. Discussion ensued on the differences in fines from Parish to Parish.

There being no other business to discuss the meeting was adjourned.

The upcoming meeting schedule was discussed. The dates are as follows: March 20, 2008 and May 15, 2008.

Darrin Naquin informed the Task Force that the Zero for December campaign was a success although there were three (3) fatalities for the month.

Melissa Menuet informed the Task Force that Angie Womack Jones had suggested a great commodity idea. The Lincoln Parish Safe Community Program gives glow in the dark mugs at sobriety checkpoints to those who have not been drinking. Non drinkers can bring their mug to a participating convenience store for a free coke. The group thought the idea was good and felt that we should get more information.

Melissa Menuet notified the group that Angie Womack Jones will no longer be the program coordinator at LHSC for the South Central Safe Community Program. Ms. Lyrica Johnson will be here replacement.

Discussion ensued on the Lifesavers Conference in Portland, Oregan April 12th - 15th. Melissa Menuet asked for clarification on the amount to be allocated to send representatives to the conference. She also asked who was interested in attending from the Task Force. Philip Poche and Antoine Rodrigue will attend the conference on behalf of the South Central Safe Community Task Force. Greg Hood will be the alternate.

It was moved by Fred Teruin, seconded by Craig Poche' to allocate \$2,280.00 to send Philip Poche and Antoine Rodrigue to the Lifesavers Conference in April 2008. Motion carried.

Melissa Menuet pointed out a copy in the handout which showed the amounts approved for the subgrants. She stated that the contracts have gone out and everyone should have received theirs.

Melissa Menuet requested any ideas that the Task Force may be interested in applying for through the DOTD Safe Routes to School Program. Discussion ensued.

Melissa Menuet stated that at the November 15th meeting she was requested to put together a letter to the legislative delegation to introduce the Task Force. She said that as requested she put together a letter which is included in the handout for

review. The committee agreed with the letter and Ms. Menuet was instructed to proceed with sending out the letter.

The next item on the agenda was Parish Reports. Craig Poché of St. James Parish stated that in the month of December there were no fatalities in their parish. Antoine Rodrigue of Lafourche Parish stated that there was one fatality in the month of December. Lanard Robinet of St. John Parish reported that there were several DWI checkpoints in the Parish. He said that units were stationed 24 hours a day at major shopping centers within the Parish during the holidays to ensure the safety of the shoppers. Greg Hood reported on a bank robbery which took place in the City of Houma. Philip Poche of Troop C reported that the troop has 6 cadets in training and their manpower will soon increase. He also stated that a helicopter would be available to help patrol the Mardi Gras parades. Keith Faul stated that they partnered with Lafourche Parish on DWI checkpoints and also conduced parking lot patrols during the month of December.

A reminder of the Highway Rail Summit and the Highway Safety Summit was given by Karla Sibille.

Betsey Tramonte of Louisiana Operation Lifesavers discussed new statistics that are available for the year 2007. She stated that fatalities were way up for the year. She spoke of a public service announcement campaign that kicked off in the spring semester. She said that 4 year colleges and universities across the state were targeted for the contest where students create a 30 second PSA for television to compete for scholarship money. The deadline for entry is April 11th.

Melissa Menuet notified the Task Force that SCPDC has began working with Ms. Rochelle St. Marie to conduct a Train the Trainer program, Drinking and Driving: It Costs too much. SCPDC and Ms. St. Marie will target the month of may to conduct the workshop.

Melissa Menuet stated to the Task Force that the Traffic Summit will be held on July 17th and asked that everyone start thinking about guest speakers for the event. The group would like to hold the event once again at the NSU Century Room.

Melissa Menuet also reminded the group that an ATV Subcommittee meeting will follow the Task Force meeting and invited any interested individual to stay.

Greg Maurin spoke of a newspaper article regarding a bill package by the Louisiana Property and Casualty Insurance Commission. He said that they are trying to prohibit drivers under 18 from driving while using a cell phone, handheld devices, text messaging devices and any other wireless communication device. He asked for comments regarding this. The committee felt that this should include everyone. Bob Canfield said that it is up to each of us to contact our legislators to push the issue. We will discuss this at the March meeting to send a letter to our legislators to support the bill. Mr. Canfield said that Col. Champagne will probably be focusing on the issue of under 21 in the bars.

Mr. Maurin stated that another initiative of the Insurance Commission is to expand the state's seat belt law to require that all vehicle occupants be buckled up.

Discussion ensued on red light running cameras.

Karen Sibille informed the Task Force of the Motorcycle Safety Awareness Committee meeting which will be held in Baton Rouge on February 19th in Classroom A at the Highway Safety Commission.

It was suggested that we try to arrange to have Col. Champagne to attend the March meeting to discuss his legislative agenda.

There being no other business to discuss, it was moved by Fred Teruin, seconded by Antoine Rodrigue to adjourn.

Melissa Menuet presented the price quotes for the designated dude and designated diva mugs. She suggested that the committee look to purchase 2500 if they decide to move forward with the program. She informed the Task Force that she had contacted a couple of bars and they seemed to be receptive. She presented a draft letter which would be sent out to the restaurants and bars in the region requesting them to partner with the Task Force on the designated driver program.

It was moved by Craig Poche, seconded by Keith Faul to approve the purchase of 2500 stadium mugs at the cost of \$1,974. Motion carried.

Melissa Menuet discussed the pencil request by Terrebonne Parish School Board. She asked for approval to purchase 5000 red pencils with safety message for the cost of \$625.00.

It was moved by Greg Hood, seconded by Craig Poche to purchase 5000 pencils for Terrebonne Parish School Board out of commodities funding. Motion carried.

Alicia Toups of ADAC discussed the success of the Alcohol and Drug Free Zone which funding was provided for through the Safe Community Sub grants.

Lyle LeBlanc updated the Committee on safety concerns being addressed in Terrebonne and Lafourche Parish including:

Turn lanes on Tunnel Blvd from Hollywood Road to past Academy will be redone with designated left and right turn lanes.

Construction of turn lane at Highway 311 and Sugarwood is upcoming.

Bayou Dularge Road overlay from Falgout Canal to Crozier. Project delayed to add raised roadway of about 4"-6". Project should be let in July.

Signals on LA 24 throughout Houma will be synchronized to try to get something similar to the Acadian Thruway. Hwy 24 is currently avoided due to the stop and go.

ITS will allow for Variable Message Signs on Hwy. 311 near Industrial and Dularge to let drivers know when the bridge is open.

On Hwy 316 in Gray for the first mile, subsurface drainage and aggregate shoulders will be added. There is a problem with pedestrians due to the lack of shoulders and sidewalks.

LA 1 in Larose is temporarily closed for repairs to the West Larose Bridge.

Hwy. 56 at Boudreax Canal will be closed soon to allow for the change of the decking on the Boudreax Canal Bridge. Detour will be through Grand Caillou. Work will take approximately 2 weeks.

Work to begin in approximately the next two weeks on the construction of a left turn lane at Klondyke at the Bourg Larose Highway.

Melissa Menuet discussed the finalized arrangements for the July 17 Traffic Summit. She gave an update on confirmed speakers as well as possible speakers.

Melissa Menuet stated that the ATV Committee has made their "Off Road Means Off Road" presentation to Houma Christian, St. Bernadette, Sixth Ward, W.S. Lafargue, Larose Upper and Greenwood School. She said that two more presentations were scheduled for Cut Off Elementary and Mulberry School. Alicia Toups added that the Committee also made the presentation to the School for Exceptional Children. Ms. Menuet added that the Committee will also try to target some of the summer programs in the area.

Under the next item Capt. Greg Maurin presented Robert Canfield with a certificate for his many years of service to the Safe Community Partnership.

The next item on the agenda was the selection of a Task Force member to attend the Lifesavers Conference in Nashville, TN. A cup was passed around and anyone interested in attending put their name in the cup. Names were pulled from the cup by Ms. Ainsworth. The person chosen to attend was Brandy Jarreau of Lady of the Sea Hospital. The alternate was Treverse Johnson of the City of Thibodaux Police Department.

Ms. Menuet discussed NHTSA Campaigns that are part of the 2009 Safe Communities contract. The two targeted NHTSA Campaigns are:

May 2009 Click It or Ticket September 2009 Drunk Driving: Over the Limit. Under Arrest.

Ms. Menuet asked if press conferences were done in the past and if this was something the group was interested in holding. Capt. Maurin stated that in the past commodities were purchased and publicity was done on a parish by parish basis. Ms. Ainsworth spoke about the campaign planners put out by NHTSA. She said the planners are a great starting point.

Ms. Hill stated that there were two issues that students in Lafourche Parish are interested in working on. She said that they were interested in doing seat belt checks at the high schools. This was something done in the past where T-shirts were given out. Help was provided by State Police and Lafourche Parish Sheriff. The other issue is the cell phone usage by the children driving in and out of the school as well as anytime they are driving. Ms. Hill said these issues are coming from the children. Ms. Ainsworth stated that in regards to teen belts, there is nothing in print yet for LHSC to share, but the two weeks prior to Click It or Ticket Campaign Louisiana is participating as a pilot state for a National teen belt campaign. She said if the Safe Communities is interested in doing something in regards to teen belts to think about doing it during the first two weeks in May. Ms. Hill suggested taking it a step further this time by not only providing T-Shirts but to give them information as well. Capt. Maurin suggested that we do something stating the groups support and possibly take a picture of the group to be sent to the newspapers.

Capt. Maurin stated that Ms. Hill mentioned the problem with cell phone usage but said the Safe Community campaign is focused on Occupant Protection and DWI. He would like to see some commodities with distracted driving but did not want to conflict with the mission of the Coalition. Sgt. Rodrigue suggested that the commodities have a duel message such as a key chain with an occupant protection message on one side and a distracted driving message on the other. Ms. Ainsworth said that is acceptable. She stated that any traffic safety message that the Coalition supports is acceptable but LHSC asks that it be a coalition decision. He stated that he would like the next batch of commodities to address the issue.

Trooper Dardar stated there have been three fatalities to date during the Zero for December campaign. Capt. Poche stated that they had a fatality on the East Bank of the Parish which is not in the Troop C area. Discussion ensued on the problems in the South Lafourche area due to the bridge being out of service. Ms. Hill stated that she notices that there seems to have more accidents on Highway 308 near the Lafourche Parish Water District.

Mr. Shirazi stated that shoulder work on a portion of LA 308 in Lafourche Parish from LA 3185 and LA 20 is scheduled to be let in April 2009. He also stated that shoulder work in Terrebonne Parish on LA 316 is scheduled to be let in April 2009.

Ms. Toups gave a brief report on the ATV Committees progress.

They are applying for the grant in the amount of \$750,000 which will be their 6th year of funding. She requested that the Safe Community Group partner with the Children's Coalition in their efforts. Through the grant they could provide overtime funds for officers, updates for computer software, etc. A representative could attend the Children's Coalitions meetings to let them know what is needed. Ms. Ainsworth stated that Highway Safety is working with that grant to insure that the youth campaign overlaps with the Over the Limit, Under Arrest Campaign.

Ms. Menuet discussed commodities for the May 2009 Click It or Ticket. Ms. Ainsworth informed the Task Force about the belt usage in the Houma area. She said that the Houma area which includes most of the Troop C area historically had the highest seat belt compliance in the State. Last year the area was at 89% usage. In November a mini survey was conducted and it showed that the Houma area dropped by 10 percentage points, still the highest in the state by only a percentage point. She said the LHSC has put it in high gear for the May 2009 Click it or Ticket Campaign. She said that LHSC and other agencies are trying to identify who the local unbelted folks are. There are a high proportion of teen unbelted fatalities and a high proportion is male, pickup driving, rural single vehicle crash, unbelted drivers. She asked that the Task Force look at targeting these particular drivers during the campaign. Ms. Ainsworth spoke about the music download cards and said that LHSC is looking outside of the box when it comes to incentives. Ms. Menuet asked that if anyone has any ideas to send her an email or call her. Ms. Ruffin-Roberson stated that the Children's Coalition also has money for commodities.

Under Parish reports each agency informed the Committee of events or activities in their jurisdiction.

Ms. Menuet reminded mini grant recipients that they need to make sure they get their signed contracts back to SCPDC. She also reminded them about budget amendments.

Ms. Menuet asked the Task Force if the felt that NSU is a good location for the Traffic Summit. She said that there were comments about the Library being hard to locate last year.
