



## **Notice and Certification to Hold Public Video Conference Meeting**

### **Region 6 Floodplain Managers Sub-Committee Meeting**

February 22, 2021

The Floodplain Managers Sub-Committee of Watershed Region 6 will hold a meeting on February 22, 2021 at 2:30 pm. This meeting is in accordance with Louisiana Watershed Initiative activities and is integral to providing a sustainable, institutional basis to increase continuity, improve flood resilience, and enable more effective flood prevention within our region.

In an effort to reduce and limit the spread of COVID-19 in Louisiana, and to preserve the health and safety of all members of the public, the Governor has declared the COVID-19 Public Health Emergency and ordered that it is necessary to limit public gatherings in a single place in an effort to avoid individuals being in close proximity to one another.

As a result of the public emergency, the limitations imposed on public gatherings and personal interactions, and the need for a number of members to travel to any physical meeting location from parishes where confirmed cases of COVID-19 have occurred, South Central Planning and Development Commission does hereby certify that in order to protect the lives, property, health, safety, and welfare of the citizens of Louisiana, it is giving the option to conduct the Floodplain Managers Sub Committee Meeting on February 22, 2021 by teleconference or video conference in order to assure the presence of a quorum of the sub-committee members.

Therefore, in accordance with Section 4 of Governor's Proclamation Number 30 JBE 2020: Additional Measures for COVID-19 Public Health Emergency, the Floodplain Managers Sub-Committee of Watershed Region 6 will hold its February 22, 2021 meeting virtually. Sub-Committee Members of Watershed Region 6 who participate virtually will utilize the online platform "Zoom" and livestream the meeting.
